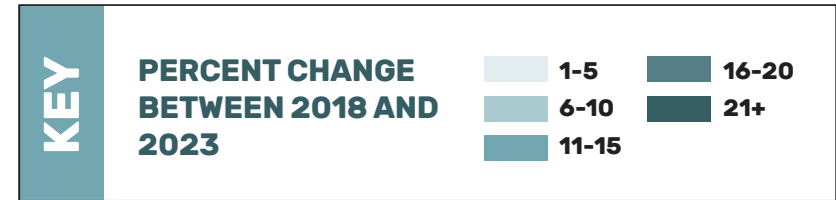

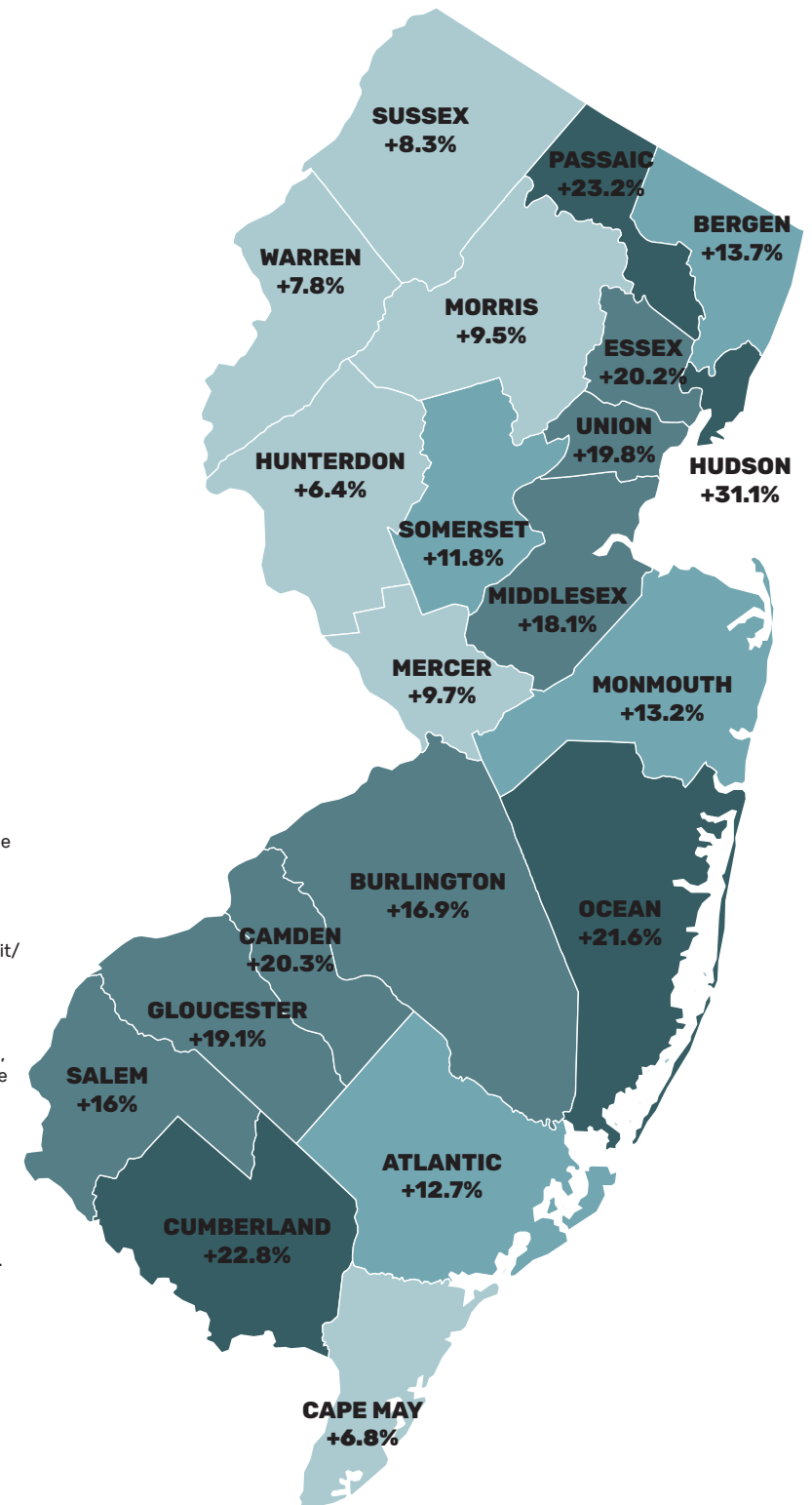

Worksite definition: A worksite is defined as a single economic unit, such as a farm, mine, factory, or store, that produces goods or services. Worksites are typically at one physical location and engaged in one, or predominantly one, type of economic activity for which a single industrial classification may be applied. A firm, or company, is a business and may consist of one or more units, where each unit may participate in different predominant economic activity. Unit v Company example: Walmart is a company (1 entity) with various stores (unit/locations/establishments/worksites).

- This is for private sector employers covered by UI.
- We produce the size class information at the worksite level, so if a company has multiple worksites in NJ, each worksite would be included in the worksite counts.
- Technically, this data series is not a true time series, but it is as close as we have. For example, some small portion of the growth in the worksites over the time period is likely attributed to better reporting of the multiple worksite locations by employers. Again, this number is small, but nonetheless should be considered. The growth in employment by size class is a little better metric over time.
