SUBJECT: Required One Stop Career Center notification posters for One-Stop Career Centers/American Job Centers

PURPOSE: This guidance delineates requirements for the display of Federal and State posters in New Jersey's One Stop Career Centers (also known as American Job Centers).

EFFECTIVE DATE: This New Jersey Workforce Innovation Notice is *effective immediately*.

POLICY OVERVIEW

Each One Stop Career Center must prominently display 27 unique, Federal and State notification posters. This guidance highlights the full list of required Federal and State posters. With a few exceptions (FMLA, MSPA), the U.S. Department of Labor's regulations do not require posting of notices in Spanish or other languages. However, if state workforce agencies (SWA) determine that other languages are spoken by a significant number or portion of the population eligible to be served or likely to be encountered, SWAs must make the translations readily available in hard copy, as appropriate to comply with the requirements at 29 CFR 38.9(g).

Please see Attachment I for a detailed list of required posters that are accessible for printing. Poster updates may be instituted according to changes deemed necessary by the U.S. Department of Labor and/or the New Jersey Department of Labor and Workforce Development.
