## Accomplishments

- Polled members on training topics and arranged for mini trainings on these topics at SRC meetings
- 2. Advocated for and received paid internships for graduate level students at local DVRS offices. It should be noted that 2 out of 3 of the students were hired for VRC1 positions. The 3<sup>rd</sup> intern opted to work in the mental health field.
- 3. Postings for VRC 1 positions now require candidates to have master's degrees.
- 4. The committee continued to review and monitor current/pending Federal and State legislation which would impact individuals who have disabilities.
- 5. Held 3 virtual public hearings
- 6. Sent letter of support to Rutgers in support of their application to receive long-term training grants from RSA.

### Goals

- 2. Review Administrative Code (DVRS' CRP unit reviewed the code and made recommendations but their findings are still in the legal department at NJDOL. Will request to see and review the work they completed and encourage needed changes based on current legislation)

- 5. Survey members about training topics for the coming year and set up mini trainings as appropriate.
- 6. Advocate for the Rehabilitation Aide position to be a non-competitive title, similar to DVRS clerical positions so the vacancies can be filled
- 7. Review MOUs as appropriate
- 8. Continue to review pertinent policies/legislation pertaining to disability related issues
- 9. Review State plan and make recommendations as needed and appropriate.

Past Year's Accomplishments of Committee:

- 1. Improved reports (2 back-to-back solid good ones now!)
  - -slides are beautiful and clearly present findings
  - -presentation with accurate and information clear
  - this has led to more information shared as well as more substantial questions asked
- 2. Response rates are improved. New DVR crew working on satisfaction surveys have re-formatted the survey request letter that, made accessing the survey more streamline, etc. This has led to double the number of responses formerly received.
