✓ ***Are there WIOA grant opportunities available?***

While there are currently no WIOA-specific grant opportunities, we anticipate grant opportunities may be developed as part of this process. Many of the industry-driven, workforce innovations already underway, such as the Opportunity4Jersey and Skills4Jersey grant programs, were developed to align resources with industry-identified needs.

✓ ***Is employer representation for WIOA a requirement; and if so, will employers be sanctioned, as adult education providers will be under WIOA?***

WIO Sec. 122 states that providers of On-the-Job-Training, customized training etc. are not subject to the same requirements as other providers. Local Areas are required to collect performance information from such providers to determine if they meet performance criteria established by the Governor. Providers that meet the criteria shall be identified as eligible providers.

✓ ***Is anyone from the Centers for Independent Living (CIL) on any of the Work Groups listed?***

The Centers for Independent Living (CIL) are valuable stakeholders. While the Work Groups do not include a CIL representative, we look forward to receiving their input throughout this process. - ✓ ***A participant emphasized the need for more Science, Technology, Engineering and Math (STEM) based training and apprenticeship opportunities.***

WIOA emphasizes experiential training such as apprenticeships, and LWD will provide guidance and technical assistance regarding incorporating these programs into the workforce system. Also, WIOA Sec. 101 requires representation from joint labor-management apprenticeship programs on the local boards. We anticipate that as a result, STEM training will be a part of those in discussions moving forward.

- ✓ ***Is the Division of Family Development (DFD) involved in the process?***

While the Division of Family Development is not a formal member of a WIOA Work Group, we value their input in this process and encourage anyone who has an interest in this process to contact us using the WIOA website email: WIOABlueprint@dol.state.nj.us and through participation in the upcoming WIOA Blueprint Conference.

- ✓ ***Is transportation being discussed since this is an important concern for rural areas?***

Yes, transportation concerns are being explored. WIOA Sec. 108 requires both Regional and Local Plans to describe the coordination of transportation and other supportive services. Also, a provision that is new to WIOA states when determining if an individual requires assistance, a One-Stop operator or partner will consider the full cost of participation in training, including costs of transposition. [WIOA Sec. 134 (c)(3)(B)(iii)]
