2. This certification acknowledges that, pursuant to the Special Ruling issued by the Division  
of Alcoholic Beverage Control on June 12, 2015, the products purchased and invoiced as a Bill  
and Hold which were part of the above-referenced Bill and Hold arrangements must be delivered  
in their entirety to \_\_\_\_\_ and/or \_\_\_\_\_ no later than 75 days (or 1<sup>st</sup>  
business day following the 75<sup>th</sup> day) from the date of issuance of the original Bill and Hold  
invoice.



3. This certification acknowledges that failure to make delivery within the timeframe set forth in the Ruling may constitute a violation of N.J.A.C. 13:2-24.1 and 24.4, in that it is discriminatory and a violation of the terms of sale.

4. This certification acknowledges that a licensee's failure to accept delivery of the product on the required date may constitute a violation of the terms of sale, which will require the Wholesaler to comply with provisions of N.J.A.C. 13:2-24.4 *et seq* and place the licensee on "COD" status.

5. This certification acknowledges that wholesaler e-mails sent to \_\_\_\_\_ shall satisfy legal process with respect to Notices of Obligation and Notices of Satisfaction.

6. I certify that any storage facility listed herein has been sanctioned by the Division of Alcoholic Beverage Control as a public warehouse facility with a license number of \_\_\_\_\_.

7. Lastly, this certification acknowledges that if violations occur, the penalty may include a license suspension by the Division of Alcoholic Beverage Control, and a prohibition against participating in Bill and Hold in the future with any Wholesaler.

8. This certification is in compliance with the terms of the Special Ruling issued by the Division of Alcoholic Beverage Control on June 12, 2015, setting forth rules relating to "Bill and Hold" and other potentially discriminatory practices in the Wholesaler Alcoholic Beverage Industry.

9. This certification shall be filed with the Wholesaler annually on July 1<sup>st</sup> and shall govern all Bill and Hold arrangements for the following license term, ending June 30<sup>th</sup>.
