

Actions of the Director

Between April 16, 2011 and April 30, 2011, the Director took the following actions and issued the following rulings:

A. Suspensions:

1. Vacated the suspension of William McLean, 140585-21, following his acquittal on criminal charges, but ordered that the revocation matter proceed

B. Registration and License Retentions (stipulations):

2. Granted the petition of Phillip Daniels to obtain casino employee registration and/or work in a non-credentialed position prior to expiration of his period of prohibition;
3. Granted the petition of Nelson Gonzalez to obtain casino employee registration and/or work in a non-credentialed position prior to expiration of his period of prohibition;
4. Granted the petition of Shawn Eric Bair to obtain casino employee registration and/or work in a non-credentialed position prior to expiration of his period of prohibition;
5. Granted the request of Juan D. Plasencia for permission to obtain non-

E. Petitions and Other Rulings:

2. Granted the request of Atlantic City Hilton to engage in complimentary distribution of pre-packed alcoholic beverages for off site consumption from a Type II CHAB location for a single event;
3. Granted the request of Trump Marina to engage in complimentary

distribution of pre-packed alcoholic beverages for off site consumption from a Type II CHAB location for a single event;

7. Waived the qualification of Polygon Management L.P. in connection with the casino licensure of Trump Entertainment Resorts;

Granted the request of AC Nightlife LLC, d/b/a DUSK, to serve alcoholic beverages on the Boardwalk in front of its premises, subject to DUSK having authorization from the city of Atlantic City, and subject to its hours of Boardwalk service being limited to noon to midnight Sunday through Thursday and noon to 2:00 AM on weekends
