DUTIES: Under the supervision of the Section Chief or Assistant Section Chief of the Environmental Enforcement and Environmental Justice Section or the Assistant Attorneys General in charge of the Affirmative Civil Enforcement Practice Group in Trenton will provide representation to the Department of Environmental Protection and other State agencies and commissions in federal and State court and perform administrative litigation to enforce a wide range of federal and State environmental laws; does other related work as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

EXPERIENCE: Two years (2) years of experience as a practicing attorney.
