DUTIES: Under direction of a Supervising Investigator or other supervisory official in the Division of Consumer Affairs, Office of Consumer Protection, conducts in-depth regulatory and administrative audits and inspections of licensed premises; reviews records, files, financial statements, and other transactions to determine compliance with rules or regulations governing state securities laws; conducts, under guidance of a team leader, civil and regulatory investigative activities or investigations, requiring specialized credentials, to detect alleged noncompliance with or violations of the New Jersey Uniform Securities Laws, administrative codes, or Professional Rules of Conduct; provides investigative information and assists in the drafting of administrative orders, administrative complaints, no-action and interpretive releases, and performs analysis of the New Jersey Uniform Securities Laws; performs other related work as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited college with a Bachelor's Degree.

EXPERIENCE: Four (4) years of experience in the conduct of civil or criminal investigations related to compliance, enforcement, detection, and surveillance activity, including the preparation of investigative reports; OR Four (4) years of experience in the conduct of investigative administrative audits and/or regulatory examinations of records maintained by businesses and organizations; OR Four (4) years of experience in the conduct of investigations for the government, the military, consumer protection programs, public advocacy organizations, or the public interest.

Applicants who do not possess the required education may substitute experience as indicated on a year-for-year basis.

Completion of a supervised internship field placement of 300 hours in an undergraduate curriculum in Criminal Justice or a related degree program may be substituted for one (1) year of the non-supervisory experience. A copy of college transcripts indicating completion of the internship as part of your undergraduate curriculum must be provided in order to meet the substitution requirement. Failure to do so may result in disqualification from consideration.

A Juris Doctorate degree or a Master's Degree in Criminal Justice, Public Administration, Business Administration, Law, or a related field may be substituted for one (1) year of the non-supervisory experience.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is required to perform the essential duties of the position.

PREFERENCE: Preference will be given to applicants with an accounting background or significant experience in conducting large, complex civil investigations involving and financial fraud or complex financial wrongdoing.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility. In addition, resumes that fail to meet the minimum requirements will not be considered.
