<u>DUTIES:</u> Under the direction of the Executive Director and/or Deputy Director, the Assistant Director of the New Jersey Racing Commission carries out assigned duties, which may involve the oversight of personnel, administration, licensing, appeals, pari-mutuel wagering, equine testing and investigations. The Assistant Director formulates policy recommendations in order to attain NJRC goals and objectives; monitors, oversees and ensures compliance with existing procedures and regulatory requirements; makes recommendations regarding organizational development and needs assessment; travel between the three (3) racetracks in Monmouth, Freehold and East Rutherford, NJ, required for work responsibilities; does additional work as assigned.

REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

EXPERIENCE: Five (5) years of experience in horse racing operations of public tracks, two (2) years of which shall been in a supervisory capacity.

Applicants who do not possess the required education may substitute experience as indicated on a year for year basis.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date.
