DUTIES: Under the supervision of the Assistant Attorneys General in charge of the Affirmative Civil Enforcement Practice Group in Trenton and/or the Section Chief of the Environmental Enforcement and Environmental Justice Sections, the Assistant Section Chief will be in charge of the Section's efforts to promote environmental justice, as well as manage priority civil enforcement actions, natural resource damage suits, and other cases. The Assistant Section Chief provides counsel and representation to all of the Section's clients; assists with planning and managing the supervision and operations of the Section; assigns matters and supervises Deputy Attorneys General in the Section; litigates and supervises litigation, as needed; evaluates the performance of assigned Deputy Attorneys General; conducts case file reviews; and, performs other duties as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney-at-Law in the State of New Jersey is required.

EXPERIENCE: Four (4) years of experience as a practicing attorney, one (1) year of which shall have been in a supervisory capacity.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

PREFERENCE: Preference will be given to applicants who demonstrate experience in the areas of environmental law, administrative practice, civil litigation, contracts and real estate transactions.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility.

While completing the application you will be instructed to upload supporting documents including, but not limited to: a resume, cover letter indicating vacancy #19-347, copy of your Certificate of Good Standing with the Supreme Court of New Jersey, a legal writing sample, unedited by others, a copy of your unofficial law school transcripts, and an Affirmative Action form.
