<u>DUTIES</u>: Under the direction of a Supervisory officer at New Jersey Training School, prepares and cooks food in large quantities; may take the lead in a group of food service workers or residents engaged in preparing, cooking, serving and storing food; involved in the transport of prepared meals; does other related duties as required.

REQUIREMENTS

EXPERIENCE: One (1) year of experience as a cook involving the preparation of a variety of food in large quantities.

NOTE: Catering experience in a delicatessen will be acceptable.

NOTE: Deli counter experience in a delicatessen will NOT be acceptable.

<u>NOTE</u>: Cooking experience in a fast food establishment will NOT be acceptable.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

<u>RESUME NOTE</u>: Eligibility determinations will be based upon information presented in resume only.
