Putting down roots and then moving on

The Soldiers of the 154th Quartermaster Company often say they aren't just members of a unit; they're part of a family. And like many families, they've put down deep roots.

For more than three decades, the water purification specialists have called the National Guard Joint Training Center at Sea Girt, N.J., their home.

That all changed over the course of a grueling 15-day annual training period in July when the Soldiers packed up their entire \$25 million inventory of heavy equipment and moved it to a new location on the edge of Joint Base McGuire-Dix-Lakehurst, N.J.

Leaving Sea Girt for the inland outpost was both a logistical challenge and an emotional hardship.

"This unit has a lot of history here in Sea Girt and all of us feel a connection," said Capt. Brennan Foley, who enlisted into this unit 17 years ago and rose to squad leader before attending Officer Candidate School.

Earlier this year, he jumped at the chance to take command of the unit and return to his roots. Then he found out his first task as commander would be planning a move to a new armory.

"On the one hand, most of us felt like we'd only leave here kicking and screaming," Foley said. "But we all recognized this unit had outgrown its space."

So the unit, which deployed to Iraq as part of the 50th Infantry Brigade Combat Team, planned its move and treated the re-location as a tactical shift from one forward operating base to another.

The unit, which has taken the nickname Black Sheep, has named its new home, The Farm.


Although the location of drill has changed for the 154th, its Soldiers insist the family feel will not.

NJNG and DMAVA employees complete Fiscal Law class

Brig. Gen. Michael Cunniff, the Adjutant General of New Jersey, presented a certificate to Linda Croteau, Construction and Facilities Management Office, for completion of the Fiscal Law class presented by the New Jersey National Guard's United States Property and Fiscal Office.

The three-day course held at the Joint Training and Training Development Center at Joint Base McGuire-Dix-Lakehurst, N.J., saw 112 civilian and uniformed employees complete the course.

In attendance were comptrollers, budget personnel, program managers, budget analysts, GPC cardholders and billing officials from both the Army and Air National Guard, along with state employees like Croteau, who are responsible for managing costs under the Master Cooperative Agreement between New Jersey Department of Military and Veterans Affairs and the National Guard Bureau.

Fiscal Law is required once every three years and instructs and tests a student's ability to ensure funds spent on a particular program meet the intent of the appropriation established by Congress. It evaluates whether the basic tenets of Purpose Time and Amount, as established in appropriation law are in compliance with federal statutes.
