<b>DEFINITION:</b>	Under direction of the director at a state institution, manages and administers all aspects of residential services within the units assigned to a section, including the supervision of personnel and the integration and coordination of programs within these units assigned; does related work as required. This position will work closely with dementia/Alzheimer's residents, Certified dementia practitioner preferred..

<b>REQUIREMENTS</b>					
<b>EDUCATION &amp; EXPERIENCE</b>	NOTE: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience. Possession of a bachelor's degree from an accredited college or university; and four (4) years of the above-mentioned professional experience, one (1) year of which shall have been in a supervisory capacity. OR Possession of a master's degree in Social Work, Psychology, Education, Administration, Sociology, Nursing, Guidance and Counseling or a closely related field from an accredited college or university; and three (3) years of the above-mentioned professional experience, one (1) year of which shall have been in a supervisory capacity. OR Eight (8) years of professional experience in work involving the direct care, training, treatment or other habilitative services to patients, clients, residents, or as a member of a treatment team in a residential or health care facility, one (1) year of which shall have been in a supervisory capacity. NOTE: "Professional experience" refers to work that is analytical, evaluative, and interpretive; requires a range of basic knowledge of the profession's concepts and practices; and is performed with the authority to act and make accurate and informed decisions.

RESIDENCY:	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after the date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.			
DRUG SCREENING:	If you are a candidate for a position that involves direct client care with the Department of Military and Veterans Affairs, you may be subject to pre and/or post-employment drug testing/ screening. The cost of any pre-employment testing will be at your expense. Candidates with a positive drug test result or those who refuse to be tested and/or cooperate with the testing requirement will not be hired.
