## JOB DESCRIPTION

<b>DEFINITION:</b>	Under direction of a supervisory official, performs consultative and liaison tasks related to federal, provider, consumer, nursing, public relations, long term institutional, home health, community care, medical, and social day care matters; does other related duties as required. Monitors compliance with federal, state, and professional guidelines, rules, and regulations. Orients new staff members and provides in-service refresher programs for professional nurses returning to hospital nursing service. Provides lectures and demonstrates new procedures for nursing service. Plans educational programs for paraprofessional nursing personnel and schedules classes in basic patient care procedures. Teaches nursing procedures by demonstration in classrooms and clinical units. Conducts meetings with trainees and with supervisors to discuss problems and ideas for improving nursing service training programs. Prepares written summaries and reports containing findings, conclusions, and recommendations. Coordinates training with all nursing service units to maintain consistency in practice and establish relationships and to point out variations of duties required by different units and on different shifts.

## REQUIREMENTS

<b>EDUCATION &amp; EXPERIENCE</b>	<b>EDUCATION:</b> Graduation from an accredited college or university with a Bachelor's degree in Nursing or related health field and a Master's degree with a major course of study in Nursing Supervision, Administration, Public Health, Medical Care, Nursing, Health Education, or related health field. <b>NOTE:</b> Applicants who do not possess the required Bachelor's degree but possess an Associate's degree in Nursing or graduated from an accredited School of Nursing may substitute two (2) years of additional clinical nursing experience as indicated. <b>NOTE:</b> Applicants who do not possess the required master's degree may substitute one (1) year of additional clinical nursing experience as indicated. <b>EXPERIENCE:</b> Six (6) years of clinical nursing experience in an acute care, long-term or community-based setting.
<b>LICENSE / CERTIFICATION:</b>	Current registration as a Professional Nurse in the State of New Jersey. Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position..

RESIDENCY:	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after the date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.
DRUG SCREENING:	If you are a candidate for a position that involves direct client care with the Department of Military and Veterans Affairs, you may be subject to pre and/or post-employment drug testing/ screening. The cost of any pre-employment testing will be at your expense. Candidates with a positive drug test result or those who refuse to be tested and/or cooperate with the testing requirement will not be hired. You will be advised if the position for which you're being considered requires drug testing and how to proceed with the testing.
