### **2212-01 Board Meeting Dates 2023**

Board Member Walter Orcutt moved the resolution, Board Member Steve Scaturro seconded it.

### **2212-02 Final adoption of the proposed regulations pertaining to the Commercial driver licensing and the mandatory lifetime revocation of a person's commercial motor vehicle driving privileges.**

This is a final adoption. The proposed rules together with the underlying legislation will positively impact public safety by permanently disqualifying persons who have been convicted of crimes of human trafficking from operating a CMV without eligibility for reduction of such disqualification. In accordance with federal law and the underlying legislation, the final adoption will impose a mandatory lifetime revocation of a person's CMV driving privileges and bar a person from applying for the restoration of such privileges in the future, if that person is convicted of an act or practice of human trafficking in violation of New Jersey law, or of "severe forms of trafficking in persons" in violation of federal law.

Board Member Steve Scaturro moved the resolution, Board Member Diane Legreide seconded it and it was unanimously adopted.
