SUBJECT: **Sunscreening Requirements (Window Tint)**

All New Jersey Motor Vehicle Commission (MVC) partners and stakeholders are hereby informed that effective April 1, 2019, there will be a new location and process for handling customer requests that require medically approved sunscreening for their vehicles. The MVC will only provide the sunscreening service by mail to the following address: New Jersey Motor Vehicle Commission, P.O. Box 403, Trenton, NJ 08666-0403.

During the qualifying process, the customer will receive a temporary 60-day Certification as proof of application, until the "Medical Exemption for Vehicle Sunscreening Certificate" is reviewed and approved. Then, upon completion of the sunscreening requirement, the customer will receive a 48-month Certification.

Notice of Window Sunscreening Authorization

This notice gives you permission to take your vehicle to an approved licensed window sunscreening (tinting) installation company to have sunscreening applied to your windshield and/or front side windows, as indicated below.

Please keep this letter in your vehicle at all times.

A list of the approved window sunscreening installation companies and the Sunscreening Installation Confirmation page is attached for your convenience.

Once sunscreening is complete, you must return the Sunscreening Installation Confirmation page (MVC Sunscreening3) within **60** days of the date of this temporary approval letter to:
