PRICE QUOTATION REQUIREMENTS:

When responding to an agency request for a contract price proposal, Contractors must provide the following minimum information, as a written proposal on their letterhead or proposal form. Proposals submitted by a Contractor's representative (i.e., dealer, distributor, etc.) may be on representative's letterhead or proposal form, but must list the contract holder's complete name, address, and contact information for a representative from the contract holder's staff for information concerning the proposal. For those price proposals provided by a Sub-contractor/Dealer, a confirming letter/email from the contract holder MUST accompany the submitted proposal confirming the quotation submitted. All proposals submitted to a State Agency or Cooperative Purchasing partner MUST include, at a minimum, the following:

<u>Please quote each of the following products listed below in quantities of 1,000; 5,000; and 10,000.</u> All items quoted <u>MUST</u> display the New Jersey Devils logo and the attached Just Drive logo. Placement of the logos is at the discretion of the vendor, and approval by Motor Vehicle Commission, Communications. Delivery <u>MUST</u> be no later than 12/7/2017, delivery will weigh in on the determination of awards.

NOTE: The list below is generic designed to meet the supply of multiple vendors. Vendors are to quote only the items they can supply. Vendors will not be disqualified if all quantities listed above cannot be quoted. The State does not guarantee that all items will be purchased, and order amounts will be on an as needed basis. Because we request a quote for 10,000 does not necessarily mean we will order 10,000 of a certain item.
