POSITION DESCRIPTION

The New Jersey Department of the Treasury, Division of Property Management & Construction is seeking a Plumber & Steamfitter. Under supervision will perform repairs on all phases of plumbing and steam systems throughout assigned facility, campus, buildings, and/or grounds. The incumbent will be responsible for the following duties: inspecting broken water, drainage, waste, and gas lines, defective closet bowls, wash basins and urinals, malfunctioning radiators, refrigerators, laundry machines, and other types of plumbing and steam fitting fixtures, fittings, appliances, and machinery; ascertaining the nature of the needed emergency or permanent repairs and performing whatever repair work is necessary; removing stoppage from waste pipes, water closets, soil stacks, and house drains, and prevents water wastage by repairing and/or replacing worn plumbing and steam fitting parts; installing toilets, showers, heating units, and other types of plumbing and steam fitting fixtures, fittings, appliances, and machinery, installing and maintaining pumps, mains, rises, headers, radiators, and auxiliary equipment for heating systems; Performs other related duties as required.

Standard workweek is Monday through Friday. Position offers a comprehensive benefits package including medical, prescription drug and dental coverage, benefit leave, Pension, supplemental pension plan, tax saving programs, and paid holidays.
