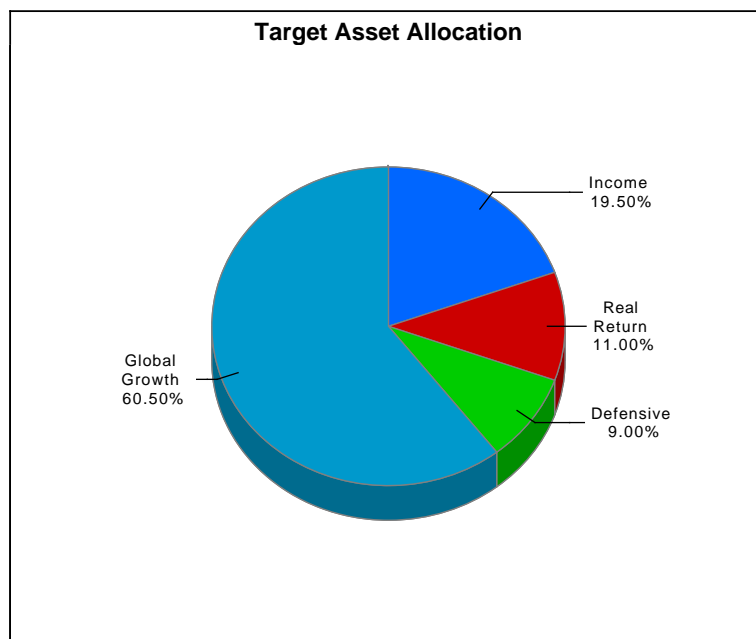
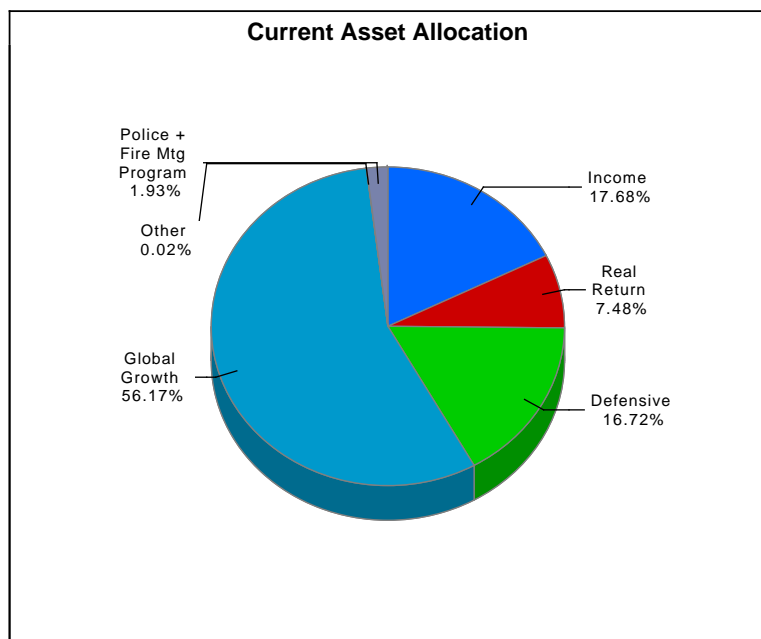

As of March 31, 2024**

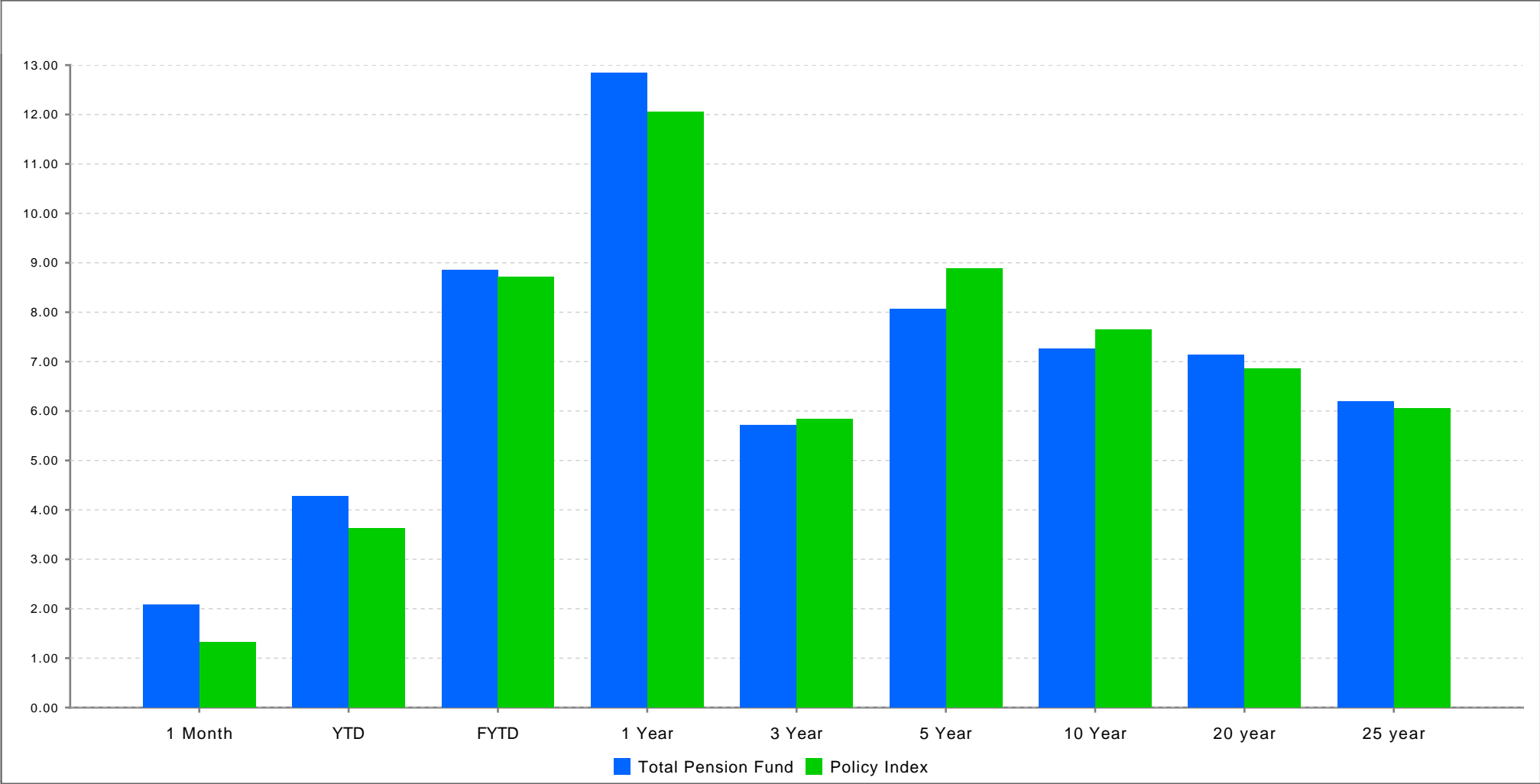

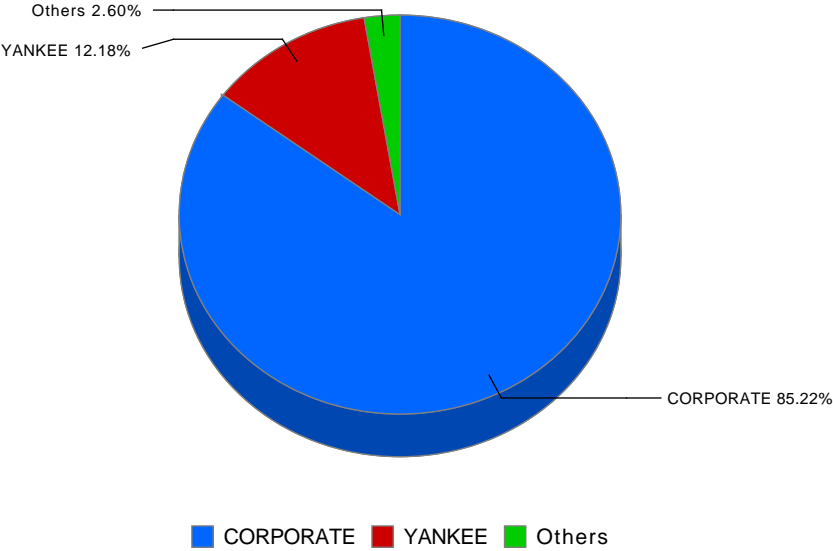
