Instructions for Form 400

1. Column A - Enter name of affiliate.
2. Column B - Enter federal identification number of the affiliate.
3. Column C - Enter the amount of tax reported on Schedule J, Part VI, line 9 from the affiliate's return (Tax with Throw Out).
4. Column D - Enter the amount of tax reported on Schedule J, Part VI, line 25 from the affiliate's return (Tax without Throw Out).
5. Column E - Enter the difference between Column C and Column D.
