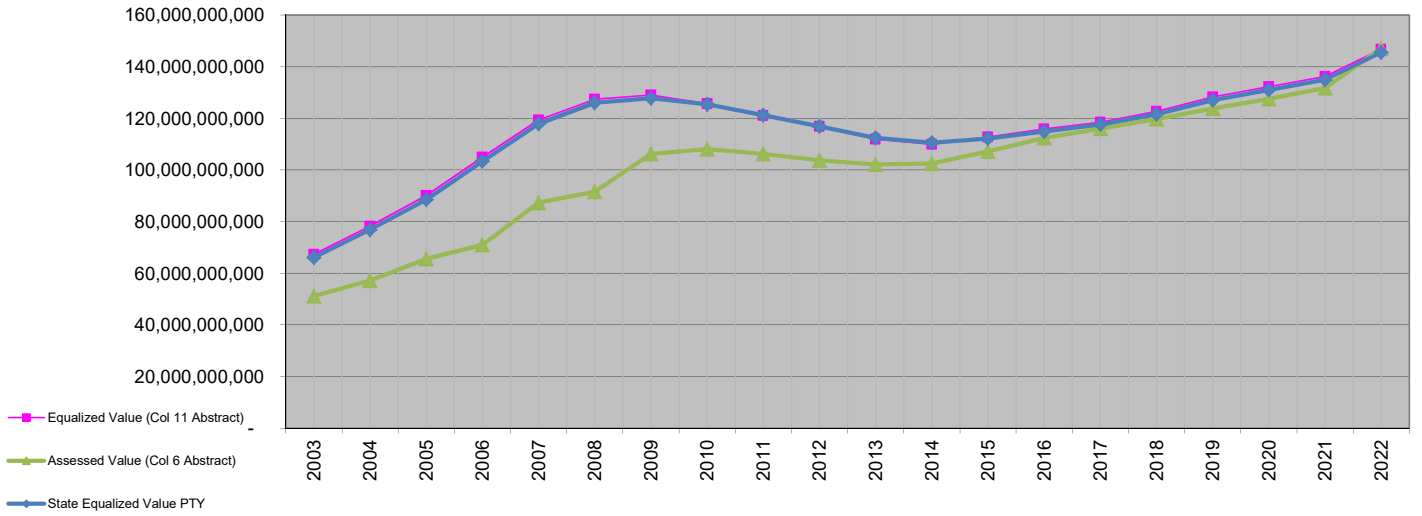

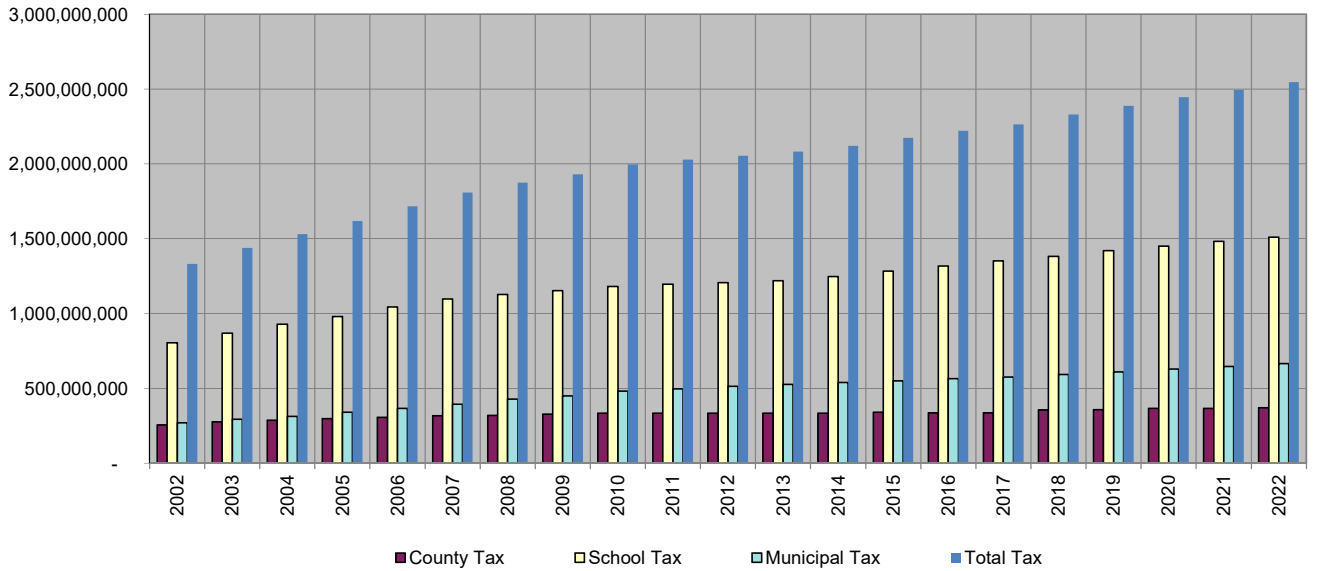

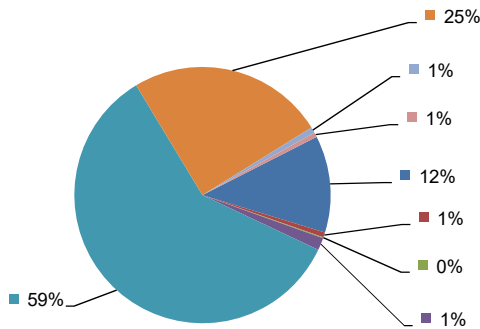
Assessment Transparency - Total Assessed to Equalized Value
