## **RESOLUTION 2024-24**

NEW JERSEY HIGHLANDS WATER PROTECTION AND PLANNING COUNCIL ADOPTION OF "RMP ADDENDUM 2024-3: HIGHLANDS AFFORDABLE HOUSING GUIDELINES" AS AN AMENDMENT OF, AND ADDENDUM TO, THE HIGHLANDS REGIONAL MASTER PLAN

**WHEREAS,** the Highlands Water Protection and Planning Act (Highlands Act or Act), N.J.S.A. 13:20-1 et seq., created a public body corporate and politic with corporate succession known as the Highlands Water Protection and Planning Council ("Highlands Council" or "Council"); and

**WHEREAS,** Section 8(a) of the Highlands Act mandates that the Council prepare and adopt a Regional Master Plan ("RMP") for the Highlands Region; and

WHEREAS, the Highlands Act provides that the RMP may be periodically revised and updated after "public hearings;" and

**WHEREAS,** on September 27, 2018, the Council adopted Resolution 2018-11 "RMP Addendum 2018-1 Procedure for Considering Proposals to Amend Highlands Regional Master Plan" (the "Amendment Procedure") as an amendment of, and addendum to, the RMP, establishing procedures to be followed by the Council for amending the RMP; and

WHEREAS, on March 20, 2024, Governor Murphy signed Bill A4/S50 (P.L.2024, c.2) setting forth new requirements for municipalities related to the provision of affordable housing; P.L. 2024, c.2 contains many references to the Highlands Region as well as the RMP and includes various requirements for the Department of Community Affairs (DCA) and municipalities in the region; and

WHEREAS, P.L.2024, c.2 requires that the Highlands Land Use Capability Zones be used by DCA to allocate affordable housing obligations in the Highlands Region; the RMP Amendment updating the Land Use Capability Zone map was adopted at the April 18, 2024, Highlands Council meeting, and has provided the DCA with the most up-to-date Highlands information on which to base their housing calculations; and

WHEREAS, to meet the additional requirements of P.L.2024, c2, an Amendment to the RMP entitled "Highlands Affordable Housing RMP Amendment," was presented at the April 18, 2024, Highlands Council meeting, which outlines the standards that will govern the potential location of affordable housing and availability of land and resources in the region; the intent of the guidance is to clearly and concisely summarize the applicable Goals, Policies and Objectives (GPOs) of the RMP that apply to affordable housing development and to update various existing GPOs to fit the requirements of P.L.2024, c2; and

WHEREAS, the Council followed the Amendment Procedure to release the "Highlands Affordable Housing RMP Amendment" for six (6) public hearings, announced by Public Notice on April 22, 2024, consisting of four (4) meetings held in various locations in the Highlands Region as well as one (1) meeting in Trenton and one (1) virtual meeting, to solicit public comment on the aforementioned RMP Amendment; and

**WHEREAS,** the 60-day public comment period concluded on June 23, 2024, and Council staff has provided the Highlands Council with its responses to all comments and other input received from interested parties during the public comment period, including any proposed changes to the "Highlands Affordable Housing RMP Amendment" based upon the public comments received; and

WHEREAS, the RMP Amendment Committee has considered all proposed changes to the "Highlands Affordable Housing RMP Amendment" and has forwarded its recommendation to the Council that it adopt the final "Highlands Affordable Housing RMP Amendment" as an amendment of, and addendum to, the RMP; and

WHEREAS, pursuant to N.J.S.A. 13:20-5.j, no action authorized by the Highlands Council to amend the RMP shall have force or effect until thirty (30) days, Saturdays, Sundays and public holidays excepted, after a copy of the minutes of the meeting of the Council has been delivered to the Governor for review, unless prior to the expiration of the review period the Governor shall approve same, in which case the action shall become effective upon such approval.

**NOW, THEREFORE, BE IT RESOLVED,** that the Highlands Council hereby adopts the final "Highlands Affordable Housing Guidelines" as an amendment of, and addendum to, the RMP.
