

## HIGHLANDS DEVELOPMENT CREDIT (HDC)

## **ALLOCATION APPLICATION**

#### **Instructions for Completing the Form**

Please note that the process of determining a property's HDC Allocation involves the reviewing of the development that could have occurred on the property on or prior to the adoption of the Highlands Act. Any information that can be supplied regarding the property such as surveys, deeds, proof of previous approvals or similar information should be submitted with the application. You must submit one application form for each block and lot. It is recommended that you contact the TDR Coordinator at (908) 879-6737 to discuss the preparation and submission of this application and any accompanying material.

#### **Owner Information**

- 1-3 Enter your first, middle, and last name, phone # and email address.
- If you own the property jointly with another person, please enter that name. If there are more than two owners, please attach an additional sheet with names and telephone numbers.
- 5, 6 Enter the owner's full mailing address.

## **Property Information**

- 7, 8 Identify the municipality and county in which the property is located.
- 9, 10 Enter the tax block and lot numbers from your most recent property tax bill. **You must submit** one application form for each block and lot.
- 11 Enter the total acreage of the property.
- 12 Enter the street address, or where one is not available, the name or route number of the road which is closest to your property.
- Note if there is one or more homes located on the property.
- 14 Note when (month and year) the home was built.
- Note if there are any other buildings on this property.
- 16 Describe the other buildings on this property, what they are used for, and when they were built.
- An exemption may permit the development of a single family home on a vacant lot. Check yes if you wish to reserve this opportunity to build a home in the future. You should do so only if you qualify to build under the current municipal zoning ordinance and an applicable Highlands Act exemption. Please be aware that this reservation does not guarantee future approval to build. In addition, certain undeveloped properties may be eligible for up to a 25% bonus in their allocation if an exemption is not reserved.
- 18 Note if there are any commercial activities conducted on this property.
- 19 Note if you owned the property on or before August 10, 2004.

#### **Additional Information**

The number of credits that are allocated to a property are partially based on the pre-Highlands Act development potential of the property. Any information that is available that may be of assistance in making this determination should be submitted (for example: copies of any previous approvals, permits, site plans, or subdivision plans).

- A copy of the deed to the property must be attached in order for your application to be processed. If it is not available, please attach a sheet explaining why it's not available.
- Note if there are any easements or deed restrictions affecting the property.
- 22 Enter the date that the easements or restrictions were recorded.
- 23 If number 21 was checked "Yes," copies of the easement or deed restrictions must be attached in order for your application to be processed. If they are not available, please attach a sheet explaining why they're not available.
- Note if you own any additional property adjoining the property for which you are applying. If number 24 is checked "Yes," please identify this property by block and lot numbers. If you are applying for an HDC Allocation for these other properties, a separate application for each property should be submitted.
- Note if you have previously submitted any application to the Department of Environmental Protection (NJDEP) for a Highlands Applicability Determination, Highlands Preservation Area Approval or applicable Highlands Act waiver concerning this property. If number 25 is checked "Yes," please provide the status of the application and submit a copy of the information provided to NJDEP and any documentation received from NJDEP.
- Note if you have ever applied for and been denied Exemption #3 from NJDEP or received a stop work order after having been granted the exemption. If "Yes" is marked, please submit any documentation received from NJDEP.
- 27 Please attach any other available property information including deeds, easements or surveys that have not been previously noted.
- Please attach any documentation regarding any previous approvals or permits on the property (if any). This does not include any building permits.
- 29 Please indicate if you have engaged an attorney or someone else to represent you. If "Yes" is checked, the Highlands Council will correspond and communicate directly with your representative and not you.
- 30-33 Please complete only if you checked the box marked "Yes" in number 29.
- 34 If you've designated a representative (see number 29), he or she must sign here.

#### **Owner Certification**

Please read the certification carefully before signing and dating the application. Any and all co-owner(s) identified in number 4 must sign and date the application as well.
