### *Program Summary*

This program will discuss the unique role of the Attorney General under the New Jersey Constitution and the specific duties of a government lawyer under R.P.C.s 1.1, 1.3, 1.4, 1.6, 1.11 and 1.13.

### *Eligibility*

This program is mandatory for Division of Law Deputy Attorneys General hired after October 2021 who have not previously completed the Basic Civil and Administrative Practice (BCAP) series of courses. DOL deputies who are required to take this program must register for all BCAP sessions.

Other Division of Law deputies are welcome to attend this program. Registrants will receive the course materials prior to the program date.

### *Faculty*

**AAG Joseph Fanaroff** provides advice to State agencies to ensure compliance with relevant ethics and conflicts of interest rules. Prior to his current assignment, AAG Fanaroff served as a Special Assistant to the Attorney General, providing strategic counsel and advice regarding the

implementation of criminal justice policy in New Jersey, with a specific focus on crime suppression, crime prevention, and prisoner reentry. Mr. Fanaroff also served on several commissions charged with examining violence in the State of New Jersey. He was a member of the Study Commission on Violence, served as a member of the Governor's Task Force for Recidivism Reduction, and as staff to the New Jersey SAFE Task Force on Gun Control. He has received the Attorney General's Award for Outstanding Service twice.

AAG Fanaroff began his career in the Department of Law and Public Safety in the Election Law Section and then served as a DAG in the Cost Recovery Section of the Environmental Practice Group. He represented the New Jersey Department of Environmental Protection in spill cleanup and natural resource recovery litigation filed against polluters of soils and groundwater. He also assisted on several complex litigation matters involving the separation of federal and state powers and appeared before the Appellate Division on behalf of the Departments of Environmental Protection, Children and Families, Corrections, and Labor and Workforce Development.

Before moving to New Jersey, AAG Fanaroff held positions at The White House and the U.S. Department of Justice. Upon his departure from federal employment, Mr. Fanaroff worked for The METEC Group, a financial services firm in Arlington, Virginia and for a legal services contractor. AAG Fanaroff received his J.D. from the George Washington University Law School and his Bachelor of Science degree in Criminal Justice, *cum laude*, from the University of Delaware.
