## WEBINAR

### *Program Summary*

The drug addiction crisis cuts across every segment of New Jersey society, without regard to class, race, gender, or profession. Lawyers are no exception; they often turn to alcohol or drugs to address the stress and anxiety of everyday work pressures and responsibilities. Mary Beth O'Connor is a Berkeley Law graduate and a retired federal judge. After battling addiction since childhood, she went to law school six years into recovery from alcohol and drugs and concluded her legal career as a federal administrative law judge. The journey of how Judge O'Connor transitioned from “junkie to judge” provides personal insight into the struggle of addiction and the journey to recovery. In addition to providing an individual story of addiction and triumph over adversity, Judge O'Connor will offer an overview of the role of addiction in the legal profession and provide guidance and resources for lawyers to find wellness.

### *Eligibility*

This program is open to attorneys in the Department of Law and Public Safety and county prosecutors' offices.

### *Faculty*

**Judge Mary Beth O'Connor** battled addiction since childhood. Six years into recovery from alcohol and drugs, she went to Berkley Law School. After graduation, she worked at a large firm in Silicon Valley, litigated class actions for the federal government and was then appointed as a Federal Administrative Law Judge. Her memoir: *From Junkie to Judge: One Woman's Triumph Over Trauma and Addiction* chronicles her history and recovery. It will be released in 2023. Judge

O'Connor has also published opinion pieces about substance use disorder and recovery in major national publications. Judge O'Connor is a Director, Secretary, and Founding Investor for She Recovers Foundation and a Director for LifeRing Secular Recovery. She regularly speaks on behalf of these organizations and about multiple paths to recovery at conferences and recovery houses and through podcasts and radio broadcasts.
