AN OFFICER MAY PURSUE WHEN

Officer reasonably believes that the violator has committed, or is engaged in a conspiracy or attempt to commit:

- any crime of the first degree
- one of the following violent or serious crimes of the second degree:
 - o Manslaughter, N.J.S.A. 2C:11-4
 - o Vehicular Homicide, N.J.S.A. 2C:11-5
 - o Aggravated Assault, N.J.S.A. 2C:12-1(b)
 - o Disarming a Law Enforcement Officer, N.J.S.A. 2C:12-11
 - o Kidnapping, N.J.S.A. 2C:13-1
 - o Luring/Enticing a Child, N.J.S.A. 2C:13-6
 - Human Trafficking, N.J.S.A. 2C:13-8
 - o Sexual Assault, N.J.S.A. 2C:14-2
 - o Robbery, N.J.S.A. 2C:15-1
 - o Arson, N.J.S.A. 2C:17-1
 - o Burglary, N.J.S.A. 2C:18-2
 - o Escape, N.J.S.A. 2C:29-5
 - o Possession of a Firearm, Explosive or Destructive Device for an Unlawful Purpose, N.J.S.A. 2C:39-4(a) through (c)
 - o Unlawful Possession of a Weapon (Machine Guns and Handguns), N.J.S.A. 2C:39-5(a) and (b)
- or one of the following other crimes:
 - o Burglary of a Dwelling, N.J.S.A. 2C:18-2
 - o Theft of a Motor Vehicle, N.J.S.A. 2C:20-3; N.J.S.A. 2C:20-2(b)(2)(b)
 - Receiving Stolen Property (Motor Vehicle Only), N.J.S.A. 2C:20-7; N.J.S.A. 2C:20-2(b)(2)(b)
 - o Bias Intimidation, N.J.S.A. 2C:16-1

OR

When an officer reasonably believes that the violator poses an imminent threat to the safety of the public or other officers, based upon the violator's actions or operation of the vehicle prior to the initiation of the attempted motor vehicle stop.
