REQUEST FOR VOLUNTARY SELF-EXCLUSION

- **ATLANTIC CITY CASINO and RACETRACK SPORTS WAGERING FACILITIES as well as INTERNET ACTIVITIES for GAMING and SPORTS WAGERING; or**
- **INTERNET ACTIVITIES ONLY for both GAMING AND SPORTS WAGERING**

NOTE: ONLY ONE SELF-EXCLUSION FORM IS REQUIRED TO SELF-EXCLUDE FROM ALL NEW JERSEY CASINOS, RACETRACK SPORTS WAGERING AND ONLINE OPERATIONS. If duplicates are submitted, the Division will accept the form that sets forth the longest self-exclusion period.

Request for Voluntary Self-Exclusion

Please read these Instructions and the Request for Voluntary Self-Exclusion Request Form including the Waiver and Release and Acknowledgment carefully. By signing and submitting the Request Form, you are agreeing to be excluded from either:

- **Atlantic City Casino and Racetrack Sports Wagering Facilities as well as Internet Activities for Gaming and Sports Wagering ; or**
- **Internet for both Gaming and Sports Wagering Only**
(*NOTE: This request can also be made directly through your online player account*)

Self-Exclusion means you cannot gamble, receive, or use complimentary goods or services, be a member of a slot or players club, receive credit from any casino, cash checks at a casino, or collect winnings or recover losses. Also, the casinos, racetracks sports wagering operators and Internet gaming license platform providers are to remove your name from their direct marketing lists.

INSTRUCTIONS

I. COMPLETING THIS FORM (NOTE: Self-Exclusion for Internet Gaming only can also be made directly through your online player account):

- A. You may schedule an appointment for an **IN-PERSON** or **VIDEO CONFERENCE** by calling the Division of Gaming Enforcement (DGE) at **1-833-788-4DGE**. All conferences are held Monday through Friday, except on state holidays.

- B. At the time you submit your Request Form, you must present identification that contains your signature **and** a photograph or physical description, such as a driver's license, passport, or military identification card. Your photograph will be taken by DGE personnel. These requirements will apply to applications submitted for video conferencing as well. When you register for your video conference you will receive specific instructions for securely submitting your required documentation via encrypted email.
- C. Your photograph and identifying information will be distributed to all New Jersey casino licensees, sportsbooks and/or internet gaming platform providers depending on the type of self-exclusion you requested. The information contained on your Request Form, the Atlantic City Casino Gambling Self-Exclusion List and the Internet Gaming Self-Exclusion List maintained by the DGE is not open to public inspection and every effort will be made to maintain its confidentiality. However, the DGE, the casinos, racetrack sports wagering facilities and the Internet gaming license permit holders are not liable for any disclosures of any information, other than a willfully unlawful disclosure. Certain limited disclosures by the casinos and Internet gaming license permit holders are permitted. For example, the casinos and Internet gaming license permit holders may inform certain of their agents, including cash advance services and junket representatives that you are on the Self-Exclusion List and the Internet Gaming Self-Exclusion List for the purposes of denying you gaming-related services. Also, the casinos and Internet gaming platform providers are permitted, by law, to disclose to affiliate gaming entities in this state or other jurisdictions that you are on the Self-Exclusion List for the limited purpose of the proper administration of responsible gaming programs administered by the affiliated gaming entities.
- D. **You should be aware that casino operators, sports wagering operators and internet platform providers might enact responsible gaming programs that are stricter than New Jersey's Self-Exclusion program for both land-based and Internet gaming.** By way of example certain Atlantic City casinos may enact a responsible gaming program in which persons signing up for state self-exclusion lists are banned from the casino's properties worldwide for the length of their state self-exclusion term. Such ban could include its gaming, hotel and entertainment venues. **ACCORDINGLY, YOU SHOULD BE AWARE THAT A CASINO or RACETRACK SPORTS WAGERING OPERATOR MAY, AS A CONSEQUENCE OF YOUR SIGNING UP FOR INTERNET SELF-EXCLUSION, BAN YOU FROM ALL OF ITS LAND BASED PROPERTIES AND FORFEIT ANY REWARDS POINTS YOU MAY HAVE EARNED.** The terms and existence of any such responsible gaming program could change, and the DGE is not responsible for keeping you informed of such changes.
- E. In accordance with Section 7 of the Privacy Act, 5 U.S.C. 552a, disclosure of your social security number to the DGE is voluntary. Failure to disclose your social security number is not grounds for denial of your request for self-exclusion. However, a delay may occur in notification to Internet gaming and sports wagering platform providers for an applicant who has not supplied a social security number or a failure to supply your social security number may compromise the effectiveness of self-exclusion procedures implemented by Internet gaming platform providers. The request for

your social security number is made pursuant to the Casino Control Act, *N.J.S.A. 5:12-1, et seq.* Your social security number will be disclosed to the casino operators, racetrack sports wagering operators, and internet gaming platform providers for their use in identifying you as a self-excluded person in order to deny you credit, check cashing and similar privileges, and for forfeiture purposes.

- F. You must choose one of the following three options in connection with the length of time that your name **must** remain on the Self-Exclusion List: one year, five years or lifetime. If you choose the one-year option, or the five-year option, you cannot request the removal of your name from the Self-Exclusion List or Internet Gaming Self -Exclusion List until the expiration of the one-year or five-year period, respectively, from the date you submitted your Request Form. Additionally, **your name will continue to remain on the Self-Exclusion List until you request its removal.** If you choose the lifetime exclusion option, your name **cannot** be removed from the Self-Exclusion List or Internet Gaming Self -Exclusion List. A request for the removal of your name from the Self-Exclusion List or Internet Gaming Self -Exclusion List may be done electronically, in person at DGE Atlantic City or Trenton offices or through video conferencing.
- G. **It is your responsibility to refrain from gaming activities.** DGE, New Jersey Racing Commission, casinos, racetrack sports wagering operators and Internet gaming platform providers are not liable for any acts or omissions in processing or enforcing your request for self- exclusion, including the failure to withhold your gaming privileges. However, if you are found gambling at a casino, racetrack sports wagering facility or on an Internet gaming site, you will be subject to forfeiture of any winnings, including any chips or tokens in your possession, electronic credits on your account, funds on your on-line gaming account which were the result of your gaming activity and you will be escorted from the gaming area or removed from the Internet gaming site. The DGE, the casinos, racetrack sports wagering operators and internet gaming platform providers also are not liable for any acts or omissions in processing or enforcing any later request by you to be removed from the Atlantic City Casino Facilities and Internet Gaming Self-Exclusion List (s).
- H. For the complete rules governing the Atlantic City Casino Facilities and Internet Gaming Self-Exclusion program, see the Casino Control Act at *N.J.S.A. 5:12-71.2* and *71.3*, as well as the regulations set forth at *N.J.A.C. 13:69G-2.1* through *2.5*. Copies of these rules are available upon request from DGE personnel and are also available on the DGE's website at www.njdge.org. Rules may be changed without prior notice to Self-Exclusion program participants.

WAIVER AND RELEASE

I hereby release and forever discharge the State of New Jersey, the Division of Gaming Enforcement and its employees and agents, and all New Jersey casino licensees, simulcasting facilities, sports wagering facilities and their employees and agents and all Internet gaming licensed platform providers from any liability to me and my heirs, administrators, executors, and assigns, for any harm, monetary or otherwise, which may arise out of or by reason of any act or omission relating to this Request for Self-Exclusion from Atlantic City Casino Facilities, Racetrack Sports Wagering Facilities and Internet Gaming and Sports Wagering activities, or my request for removal from the Self-Exclusion List(s) for Atlantic City Casino Facilities, Racetrack Sports Wagering Facilities and Internet Gaming and Sports Wagering activities including: 1) its processing or enforcement; 2) the failure of a New Jersey casino licensee and Internet gaming licensed permit holder to withhold gaming privileges from, or to restore gaming privileges to me; 3) permitting me to engage in gaming activity in a licensed casino, racetrack sports wagering facility, simulcasting facility or on sites of Internet gaming license platform providers while on the list of self-excluded persons; and 4) disclosure of the information contained in the self-exclusion request or list, except for a willfully-unlawful disclosure of such information.

ACKNOWLEDGMENT FOR SELF EXCLUSION FOR ATLANTIC CITY CASINOS, RACETRACK SPORTS WAGERING FACILITIES AND INTERNET GAMING AND SPORTS WAGERING ACTIVITIES

I am voluntarily requesting exclusion from all gaming activities offered by New Jersey licensed casinos and sports wagering facilities. This includes sports wagering facilities at New Jersey racetracks and internet gaming and sports wagering activities. I certify that the information that I have provided above is true and accurate, and that I have read and understand and agree to the waiver and release included with this request for self-exclusion. I am aware that my in-person actual or digital signature below authorizes the Division of Gaming Enforcement to direct all New Jersey casino licensees, racetrack sports wagering facilities and internet gaming platform providers to restrict my gaming activities in accordance with this request and, unless I have requested to be excluded for life, until such time as the DGE removes my name from the self-exclusion list in response to my written request to terminate my voluntary self-exclusion. I am aware and agree that during any period of self-exclusion any money or thing of value seized from me, or owed to me by, a casino licensee, racetrack sports wagering facility and internet gaming platform provider shall be subject to forfeiture.

ACKNOWLEDGMENT FOR INTERNET GAMING AND SPORTS WAGERING ACTIVITIES SELF EXCLUSION

I am voluntarily requesting exclusion from all New Jersey Internet gaming activities. I certify that the information I have provided is true and accurate, and that I have read and understand and agree to the waiver and release included with this request for Internet self-exclusion. I am aware that my in-person actual or digital signature authorizes the Division of Gaming Enforcement to direct all New Jersey casino licensees, racetrack sports wagering operators and internet gaming platform providers to restrict my Internet gaming in accordance with this request and until such time as the Division removes my name from the Internet self-exclusion list in response to my request to terminate my voluntary Internet self-exclusion. I am aware and agree that during any period of Internet self-exclusion any money or thing of value seized from me, or owed to me by, a casino licensee shall be subject to forfeiture.

I acknowledge the fact that casino operators, racetrack sports wagering operators and internet gaming platform providers might enact responsible gaming programs that are stricter than New Jersey's Self-Exclusion program. By way of example, a casino operator may enact a more restrictive responsible gaming program in which persons signing up for state self-exclusion lists are banned from all of their casino properties worldwide for the length of the state self-exclusion terms. Any request for online exclusion COULD, at the sole discretion of the casino operator also apply to land-based casinos and gambling facilities. By initiating this online gaming and sports wagering exclusion, I agree not to gamble at any online casino offered by a New Jersey casino licensee, racetrack sports wagering operator, internet gaming platform provider or its partners or affiliates. I understand that individual casino operators, racetrack sports wagering operators and internet gaming platform providers have the right to change their responsible gaming programs to exclude me from their land-based casinos even if I sign up only for the State's online gaming self-exclusion list. I understand the Division is not responsible for keeping me informed of any changes.
