- 2. "Three-of-a-kind suited" is a hand consisting of three cards of the same rank and suit (identical cards);
- 3. "Straight flush" is a hand consisting of three cards of the same suit in consecutive ranking;
- 4. "Three-of-a-kind" is a hand consisting of three cards of the same rank;
- 5. "Straight" is a hand consisting of three cards of any suit in consecutive ranking;
- 6. "Flush" is a hand consisting of three cards of the same suit; and
 - 7. "Pair" is a hand consisting of two cards of the same rank.
- (c) For purposes of the four card bonus wager, the rank of the cards, in order of highest to lowest rank, shall be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3 and 2. Notwithstanding the foregoing, an ace may be used to complete a "royal flush," "straight flush" or "straight formed with a 2, 3 and 4. The four card hands recognized for payout in accordance with (h)2 below, in order from highest to lowest rank, shall be:
- "Four-of-a-kind suited" is a hand consisting of four cards of the same rank and suit (identical cards);
- 2. "Royal flush" is a hand consisting of an ace, king, queen and jack of the same suit;
- 3. "Straight flush" is a hand consisting of four cards of the same suit in consecutive ranking;
 - "Four-of-a-kind" is a hand consisting of four cards of the

same rank;

- 5. "Straight" is a hand consisting of four cards of any suit in consecutive ranking;
- 6. "Flush" is a hand consisting of four cards of the same suit;
 - 7. "Two pair" is a hand consisting of two "pair;"
- 8. "Three-of-a-kind" is a hand consisting of three cards of the same rank; and
- 9. "High Pair" is a hand consisting of two cards of the same rank (Sixes through Aces).
- (d) For purposes of the five card bonus wager, the rank of the cards, in order of highest to lowest rank, shall be: ace, king, queen, jack, 10, 9, 8, 7, 6, 5, 4, 3 and 2. Notwithstanding the foregoing, an ace may be used to form a "royal flush," a "straight flush" or a "straight" formed with a 2, 3, 4 and 5. The five card hands recognized for payout in accordance with (h)3 below, in order from highest to lowest rank, shall be:
- "Royal flush" is a hand consisting of an ace, king,
 queen, jack and ten of the same suit;
- 2. "Straight flush" is a hand consisting of five cards of the same suit in consecutive ranking;
- 3. "Five-of-a-kind" is a hand consisting of five cards of the same rank regardless of suit;
- 4. "Four-of-a-kind" is a hand consisting of four cards of the same rank regardless of suit;
 - 5. "Full house" is a hand consisting of "three-of-a-kind"

and a pair;

- 6. "Flush" is a hand consisting of five cards of the same suit regardless of rank;
- 7. "Straight" is a hand consisting of five cards of consecutive rank regardless of suit;
- 8. "Three-of-a-kind" is a hand consisting of three cards of the same rank regardless of suit;
 - 9. "Two pair" is a hand consisting of two "pair;" and
- 10. "Pair" is hand consisting of two cards of the same rank.
- (e) A three card bonus wager, four card bonus wager or five card bonus wager shall have no bearing on any other wager made by a player at the game of blackjack.
- (f) Prior to the first card being dealt for each round of play, each player who has placed a blackjack wager in compliance with N.J.A.C. 13:69F-2.3(a) may make an three card bonus wager, a four card bonus wager or a five card bonus wager by placing gaming chips, plaques or, if applicable, a match play coupon on the appropriate area of the blackjack layout, except that a verbal wager accompanied by cash may be accepted, provided that it is confirmed by the dealer and casino supervisor at the table prior to the first card being dealt to any player and such cash is expeditiously converted into gaming chips or plaques. The minimum and maximum of the bonus wagers permitted by a casino licensee shall be posted in accordance with N.J.A.C.
 - (g) The dealer shall then announce "No more bets" and deal the

initial two cards to all players and the dealer in accordance with N.J.A.C 13:69F-2.6(e), (j) or (k). Prior to any additional cards being dealt to any player at the table and before any card reader device is utilized, the dealer shall, starting with the player farthest to his or her right and continuing counterclockwise around the table, settle in succession all bonus wagers by collecting all losing wagers and paying all winning wagers in accordance with (f) below.

- (h) All winning bonus wagers shall be paid at no less than the odds for the player's highest ranking hand in a pay table pre-selected by the casino licensee and posted at the table pursuant to N.J.A.C. 13:69F-8.3.

- 2. The dealer's initial face up card and the player's initial two cards from the player's two hands form a five card poker hand recognized for payout in (i)2 below.
- (b) For purposes of the four card progressive wager, the provisions of N.J.A.C. 13:69F-2.34(c) shall apply.
- (c) For purposes of the five card progressive wager, the provisions of N.J.A.C. 13:69F-2.34(d) shall apply, with the addition

of the two highest ranking hands that qualify for a payout of a percentage of the progressive meter as follows:

- "Diamond royal flush" is a hand consisting of an ace, king, queen, jack and ten, all of diamonds; and
- 2. "Other royal flush" is a hand consisting of an ace,
 king, queen, jack and ten, all of the same suit other than diamonds
 (i.e., hearts, spades or clubs).
- (d) A four card progressive wager or five card progressive wager shall have no bearing on any other wager made by a player at the game of blackjack.
- (e) Prior to the first card being dealt for each round of play, each player who has placed a blackjack wager in compliance with N.J.A.C. 13:69F-2.3(a) may make a four card progressive wager or a five card progressive wager, as applicable, by placing a wager at his or her betting position in conformity with the approved progressive wagering system. The amount of the progressive wager permitted by a casino licensee shall be posted in accordance with N.J.A.C. 13:69F-8.3. Once such wagers have been placed, the dealer shall activate the approved progressive wagering system indicating that a progressive wager has been made at the appropriate betting position(s). In accordance with N.J.A.C. 13:69E-1.10(j), the dealer shall ensure that only one progressive wager has been made for each betting position.
- (f) The dealer shall announce "No more bets" and register the progressive wagers on the progressive meter and reset the meter, if applicable. The dealer shall then deal the initial two cards to all

players and the dealer in accordance with N.J.A.C 13:69F-2.6(e), (j) or (k). Prior to any additional cards being dealt to any player at the table and before any card reader device is utilized, the dealer shall, starting with the player farthest to his or her right and continuing counterclockwise around the table, settle in succession all progressive wagers, by collecting all losing wagers and paying all winning wagers in accordance with (i) below.

- (f) Prior to making a payout for a winning progressive wager, the dealer shall:
 - 1. Verify that the player's hand is recognized for payout;
- Verify that the progressive wagering system has accepted the wager; and
- 3. Have a casino supervisor validate the progressive wager payout pursuant to the casino licensee's internal controls.
- (g) All payouts that are a percentage of the amount of the progressive meter shall be paid in accordance with the amount on the primary meter when the player's blackjack wagers are settled pursuant to N.J.A.C. 13:69F-2.3(e), provided, however:
- 1. For the four card progressive wager, if more than one player at the table has qualified for a percentage of the amount on the progressive meter, each player shall share equally in the total amount on the progressive meter;
- 2. For the five card progressive wager, if more than one player at a table has qualified for a payout of a percentage of the amount on the progressive meter, those who qualify for 10% of the progressive meter amount shall be paid first, and then those who

qualify for 100% of the progressive meter amount shall be paid in equal amounts from the balance;

- 3. Percentage payouts of the meter amount are fixed regardless of the amount of the player's progressive wager; and
- 4. If a player who has won a progressive wager payout that is not paid from the table inventory container, the cards of that player shall not be collected until the necessary documentation has been completed pursuant to the rules of the Division.
- (h) The rate of progression for the progressive meter or, if applicable, the reset meter and progressive meter combined, shall be no less than 50%. The initial amount placed on the progressive meter by the casino licensee and portion of the reset amount funded by the casino licensee shall be established by each casino licensee in accordance with the rules of the Division.
- (i) All winning progressive wagers shall be paid for the highest single payout for a poker hand achieved by a player. Payouts shall be made in accordance with a pay table pre-selected by the casino licensee and posted at the gaming table pursuant to N.J.A.C. 13:69F-8.3 for the designated number decks used in the game as set forth below.
