DUTIES: Under the supervision of a Supervisory officer at a Juvenile Justice Commission facility, prepares and cooks food in large quantities; may take the lead in a group of food service workers or residents engaged in preparing, cooking, serving and storing food; involved in the transport of prepared meals; does other related duties as required.

REQUIREMENTS

EXPERIENCE: One (1) year of experience as a cook involving the preparation of a variety of food in large quantities.

NOTE: Catering experience in a delicatessen will be acceptable.

NOTE: Deli counter experience in a delicatessen will NOT be acceptable.

NOTE: Cooking experience in a fast food establishment will NOT be acceptable.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

SPECIAL NOTE: Appointment to this title will be made provisionally, pending the outcome of an open-competitive examination. If selected for the position, you must apply for the open-competitive examination, when issued by the Civil Service Commission, pass and be reachable on the resulting eligible list to be permanently appointed to the title.

RESUME NOTE: Eligibility determination will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide a evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility.
