<u>DUTIES</u>: Under direction of the Director or Deputy Director of the Budget and Grant Operations Section and/or an Administrative Analyst 4, Department of Law and Public Safety, performs the review of Federal and State grants, sub-grant contracts and financial documentation to ensure allowable expenses while adhering to grant conditions, regulations and procedures, for proper utilization of Federal and State resources; performs ongoing analysis for the appropriate distribution of grant funds to sub recipients; reviews programmatic reports to ensure goals and objectives being met; does other related duties as required.

## **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited college or university with a Bachelor's degree.

**EXPERIENCE:** Three (3) years of experience involving the review, analysis, and evaluation of budget, organization, administrative practices, operation methods, management operations, or data processing applications, or any combination thereof, which shall have included responsibility for the recommendation, planning, and/or implementation of improvements in a business or government agency.

**NOTE:** A Master's degree in Public Administration, Business Administration, Economics, Finance, or Accounting may be substituted for one (1) year of indicated experience.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**RESUME NOTE:** Eligibility determinations will be based upon information presented in resume only.
