<u>DUTIES</u>: Under the direction of a supervisory official in the Division of Highway Traffic Safety, Department of Law and Public Safety, reviews and evaluates highway safety grant applications in relation to need, capability, and priority; visits, consults, and provides technical assistance to grantees concerning highway safety projects; monitors progress of highway safety projects and prepares interim progress, evaluation, and monitoring reports on each specific project under his/her jurisdiction; may address various public and private groups in order to define and accentuate the functions and objectives of the State's overall roadway safety programs; performs other related duties as required.

SPECIAL SKILL: Applicants must be able to read, write, speak, understand, or communicate in Spanish and English sufficiently to perform the duties of this position.

REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

EXPERIENCE: One (1) year of experience in the development, implementation, and review of programs and/or procedures.

NOTE: Applicants who do not possess the required education may substitute additional experience as indicated on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

RESUME NOTE: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date.
