**DUTIES:** Under direction of the Department's Chief Ethics & Compliance Officer, the Deputy Attorney General, Ethics & Compliance, will provide legal support to the newly created Ethics & Compliance Office. The DAG, Ethics & Compliance, will assist in the execution of compliance reviews, employee-related investigations and internal audits. This individual also will serve as an Ethics Liaison Officer for the Division of Administration and Office of the Attorney General.

### **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice law in the State of New Jersey is required.

**EXPERIENCE:** Deputy Attorney General 4: Two (2) years of experience as a practicing attorney.  
Deputy Attorney General 3: Three (3) years of experience as a practicing attorney.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**PREFERENCE:** Preference will be given to attorneys who have experience performing investigations, writing or reviewing investigative reports, and with application of government policies, rules and regulations. Preference will also be given to attorneys who have experience interpreting the Uniform Ethics Code and Conflicts of Interest Law.

**SPECIAL NOTE:** Current Department employees appointed to a Deputy Attorney General title must be willing to accept a lateral transfer, if selected.

**RESUME NOTE:** Eligibility determinations are based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in your ineligibility.
