**DUTIES:** Under the supervision of Assistant Attorneys General in the Financial Affairs Practice Group, the Section Chief and/or the Assistant Section Chief of the Pensions and Financial Transactions Section (PFT) is responsible for handling a wide range of complex financial transactions. The PFT Section also represents the NJ Office of Public Finance with respect to all State public finance transactions and representing various NJ authorities who issue municipal bonds to finance various projects. Other duties include contract drafting, review and negotiation, State law compliance, State financial litigation support, complex financial transactions, including, but not limited to, redevelopment transactions, corporate securities and debt financing transactions, public finance, or bank lending transactions and public-private partnership transaction; performs other duties as required.

### **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

**EXPERIENCE:** Two years (2) years of experience as a practicing attorney.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**PREFERENCE:** Preference will be given to applicants with experience in the areas of complex financial transactions, including, but not limited to, redevelopment transactions, corporate securities and debt financing transactions, public finance, bank lending transactions, or public-private partnerships.

**RESUME NOTE:** Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so will result in your ineligibility.
