DUTIES: The Senior Executive Service position will serve as a chief technology officer that provides strategic vision, innovation, leadership, and oversight to ensure information technology initiatives are aligned with the New Jersey State Police's (NJSP) mission, goals, and objectives. Work involves establishing and executing the NJSP's information technology strategic plan, goals and objectives; developing policies, procedures, and guidelines; establishing priorities, standards, and measurement tools for determining progress in meeting goals; coordinating and evaluating program activities or business functions; and coordinating the development and management of the information technology budget. This role directs through subordinate managers and supervisors, programs of work involving all aspects of the NJSP's information technology systems and services. This role acts as an expert advisor to executive leadership on all matters related to information technology. Incumbents in this role work under minimal supervision, with extensive latitude for the use of initiative and independent judgment.

REQUIREMENTS

EDUCATION: Bachelor's Degree from an accredited college or university with major course work in computer science, management information systems, or business administration.

EXPERIENCE: Minimum of 10 years of progressively responsible professional experience in information technology services with five (5) years of demonstrated and progressively responsible managerial experience. Proven and demonstrable experience with large, moderately to highly complex projects.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

RESUME NOTE: Eligibility determinations will be based upon information presented in the resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date.
