COUNT ONE

(Unlawful Disposition of a Firearm - Fourth Degree)

WILLIAM IVERY


between on or about March 29, 2005, and on or about October 7, 2006, at the Township of Hamilton, in the County of Mercer, elsewhere, and within the jurisdiction of this Court, knowingly did dispose of a firearm, that is, a Jennings .380 caliber handgun, model T380, bearing serial number 1475142, and a Jennings .380 caliber handgun, model T380, bearing serial number 1472663, without being licensed or registered to do so as provided in N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Unlawful Possession of a Firearm - Third Degree)


WILLIAM IVERY

INDICTMENT

The Grand Jurors of and for the State of New Jersey, upon
their oaths, present that:

COUNT ONE

(Conspiracy - Third Degree)

WILLIAM IVERY

RONALD BLAKELY, JR.

and

ABDUL SMITH

between on or about July 1, 2007, and in or about August 27,
2007, at the Township of Maple Shade, in the County of
Burlington, at the City of Trenton and at the Township of
Hamilton, both in the County of Mercer, in the State of Texas,
elsewhere, and within the jurisdiction of this Court, with the
purpose of promoting or facilitating the commission of the crimes
of unlawful disposition of a firearm, unlawful possession of a

firearm, and violation of the regulatory provisions relating to firearms, did agree that:

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or

B. One of more them knowingly would aid in the planning, solicitation, or commission of said crimes, that is:

1. Knowingly to dispose of a firearm without being licensed or registered to do so as provided in N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d.

2. Knowingly to possess a firearm without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b.

3. Knowingly to receive, purchase, or otherwise acquire a handgun without being licensed as a dealer under N.J.S.A. 2C:58-1 et seq., or having first secured a permit to purchase a handgun as provided by N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-10.

OVERT ACTS

The Grand Jurors aforesaid, upon their oaths, do further present that in pursuance of the said conspiracy, the following OVERT ACTS, among others were committed:

1. In or about July 2007, ABDUL SMITH contacted RONALD BLAKELY, JR., both residents of New Jersey, and ABDUL SMITH asked RONALD BLAKELY, JR., to obtain a firearm for him.

2. RONALD BLAKELY, JR., then called WILLIAM IVERY and asked him to purchase a firearm in Texas and send it to New Jersey.

3. On August 20, 2007, WILLIAM IVERY purchased a Smith & Wesson .40 caliber handgun Model SW40VE, Serial Number RAU1005, from Guns Gallore in Killeen, Texas. On the same date, WILLIAM IVERY mailed the handgun to a residence in Maple Shade, New Jersey.

4. Approximately one week later, RONALD BLAKELY, JR., and ABDUL SMITH drove to Maple Shade, New Jersey, where the Smith & Wesson .40 caliber handgun, Model SW40VE, Serial Number RAU1005, was given to RONALD BLAKELY, JR., who gave the weapon to ABDUL SMITH.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Unlawful Disposition of a Firearm - Fourth Degree)

WILLIAM IVERY

and

RONALD BLAKELY, JR.

between on or about August 20, 2007, and on or about August 27, 2007, at the Township of Maple Shade, in the County of Burlington, in the State of Texas, elsewhere, and within the jurisdiction of this Court, knowingly did dispose of a firearm, that is, a Smith & Wesson .40 caliber handgun, model SW40VE, bearing serial number RAU1005, without being licensed or registered to do so as provided in N.J.S.A. 2C:58-1 et seq., contrary to the provisions of N.J.S.A. 2C:39-9d and N.J.S.A. 2C:2-6, and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Unlawful Possession of a Firearm - Third Degree)

RONALD BLAKELY, JR.

and another individual whose identity is known to the Grand Jurors, who is named as a coconspirator but not as a defendant in this Count, on or about August 27, 2007, at the Township of Maple Shade, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, knowingly did possess a firearm, that is, a Smith & Wesson .40 caliber handgun, model SW40VE, bearing serial number RAU1005, without having first obtained a permit to carry same as provided in N.J.S.A. 2C:58-4, contrary to the provisions of N.J.S.A. 2C:39-5b, and against the peace of this State, the government and dignity of the same.

COUNT FOUR


(Violation of the Regulatory Provisions Related
to Firearms - Fourth Degree)

RONALD BLAKELY, JR.

and

ABDUL SMITH

on or about August 27, 2007, at the Township of Maple Shade, in the County of Burlington, elsewhere, and within the jurisdiction of this Court, knowingly did receive, purchase, or otherwise acquire a handgun, that is, a Smith & Wesson .40 caliber handgun, model SW40VE, bearing serial number RAU1005, without being licensed as a dealer under N.J.S.A. 2C:58-1 et seq., or having first secured a permit to purchase a handgun as provided by N.J.S.A. 2C:58-3, contrary to the provisions of N.J.S.A. 2C:39-10, and against the peace of this State, the government and dignity of the same.
