COUNT ONE

(Conspiracy - Second Degree)

who are named as defendants herein, and other persons whose identities are both known and unknown to the Grand Jurors, who are named as co-conspirators but not as defendants herein, between on or about March 3, 2016 and on or about June 28, 2016, at the City of Newark, in the County of Essex, elsewhere, and within the jurisdiction of this Court, with the purpose of promoting or facilitating the commission of the crimes of Possession with Intent to Distribute a Controlled Dangerous Substance, Possession with Intent to Distribute and/or Distribution within 1,000 feet of School Property, Possession with Intent to Distribute and/or Distribution within 500 feet of a Public Property, and Distribution of a Controlled Dangerous Substance, did agree that:

A. One or more of them knowingly would engage in conduct which would constitute the aforesaid crimes, or

B. One or more of them knowingly would aid in the planning, solicitation, or commission

of said crimes, that is:

1. Knowingly possess with intent to distribute a controlled dangerous substance, that is, heroin, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(2) and N.J.S.A. 2C:35-5c; and

2. Knowingly distribute a controlled dangerous substance, that is, heroin, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(2) and N.J.S.A. 2C:35-5c;

3. Knowingly possess with intent to distribute a controlled dangerous substance, that is fentanyl, a Schedule II narcotic drug, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(5) and N.J.S.A. 2C:35-5c; and

4. Knowingly distribute a controlled dangerous substance, that is, fentanyl, a Schedule II narcotic drug, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(5) and N.J.S.A. 2C:35-5c;

5. Knowingly possess with intent to distribute a controlled dangerous substance, that is heroin and/or fentanyl, in violation of N.J.S.A. 2C:35-5a(1), within 1,000 feet of the Miller Elementary School and/or Louise A. Spencer Elementary School, which are owned by or leased to the Newark Board of Education and used for school purposes, contrary to the provisions of N.J.S.A. 2C:35-7; and

6. Knowingly possess with intent to distribute and/or distribute a controlled dangerous substance, that is heroin and/or fentanyl, in violation of N.J.S.A. 2C:35-5a(1), within 500 feet of the Jesse Allen Park, contrary to the provisions of N.J.S.A. 2C:35-7.1.

All in violation of N.J.S.A. 2C:5-2, and against the peace of this State, the government and dignity of the same.




