1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

****CONTINUATION OF COMPLAINT S 1025 2021 000019****

THE EVIDENCE INDICATES THAT BETHEA KNOWINGLY SUBMITTED A FALSE REPORT REGARDING THE INCIDENT. IN A SPECIAL CUSTODY REPORT COMPLETED AND SIGNED BY BETHEA, HE STATED THAT VICTIM 1 STATED THAT SHE WANTED TO "KILL HERSELF." NO OFFICERS CALLED A CODE 66 OR CODE 53, PROCEDURES WHICH ARE REQUIRED TO BE IMPLEMENTED WHEN INMATES ARE SUICIDAL OR IN THE EVENT OF A MEDICAL EMERGENCY. VICTIM 1 DENIED THREATENING SUICIDE. BETHEA'S FILING OF AN OFFICIAL DOC REPORT THAT HE KNEW TO CONTAIN FALSE INFORMATION VIOLATES THE DEPARTMENT OF CORRECTIONS RULES AND REGULATIONS ARTICLE II, SECTION 7 AND SECTION 8. BY FILING A FALSE REPORT, BETHEA INTENDED TO DECEIVE OTHERS WITHIN THE DOC INTO BELIEVING THAT THE USE OF FORCE ON VICTIM 1 WAS JUSTIFIED. BETHEA ALSO SUPERVISED THE EXTRACTION OF VICTIM 2. BETHEA'S SPECIAL CUSTODY REPORT STATES VICTIM 2 REFUSED ALL ORDERS TO BE PLACED IN HANDCUFFS. BETHEA THEN DEPLOYED PEPPER SPRAY INTO VICTIM 2'S CELL. VICTIM 2 WAS NOT HANDCUFFED AT THAT TIME. BETHEA DID NOT GIVE VICTIM 2 THE TIME REQUIRED TO COMPLY, AS REQUIRED BY DOC CUSTODY DIRECTIVE 33, IV(F). DOC OFFICERS SUPERVISED BY BETHEA THEN ENTERED VICTIM 2'S CELL TO FORCIBLY REMOVE HER. DURING THE EXTRACTION, AN OFFICER STRUCK VICTIM 2 IN THE FACE WITH A CLOSED FIST APPROXIMATELY 28 TIMES, EVEN THOUGH VICTIM 2 WAS NOT RESISTING. BETHEA DID NOT INTERVENE TO STOP THE OFFICERS' IMPROPER USE OF FORCE, WHICH VIOLATED DOC POLICIES THAT ONLY ALLOW FOR THE OBJECTIVELY REASONABLE AND NECESSARY USE OF FORCE. DESPITE VICTIM 2 SUSTAINING VISIBLE INJURIES TO HER MOUTH AND LIP DURING THE EXTRACTION, BETHEA DID NOT DISCLOSE VICTIM 2'S INJURIES IN HIS SPECIAL CUSTODY REPORT AS REQUIRED BY CUSTODY DIRECTIVE 34, IV(I), WITH THE INTENT TO DECEIVE OTHERS WITHIN THE DOC AS TO VICTIM 2'S INJURIES AND TO DECEIVE OTHERS WITHIN THE DOC INTO BELIEVING THAT THE USE OF FORCE ON VICTIM 2 WAS JUSTIFIED. IMMEDIATELY UPON ENTERING THE CELL OF INMATE 2, CO PUNCHES AND STRIKES INMATE 2 WITH A CLOSED FIST APPROXIMATELY 28 TIMES IN THE FACE AREA, ALTHOUGH INMATE 2 HAS HER ARMS UP, ATTEMPTING TO COVER HER FACE, AND WHILE STANDING PRESSED UP AGAINST A WALL WITH HER BACK FACING THE OFFICERS, OR ATTEMPTING TO PROTECT HERSELF. DOC POLICY ONLY PERMITS USE OF FORCE THAT IS OBJECTIVELY NECESSARY AND REASONABLE. EXCESSIVE OR UNREASONABLE FORCE VIOLATES DOC CUS.001.UOF.002, IIIA. CO'S USE OF FORCE AGAINST INMATE 2 RESULTED IN SERIOUS BODILY INJURIES, INCLUDING CONCUSSION AND FACIAL INJURIES.
