## **Unique Authorities**



One of the NJSP Port Security Section's core functions is regulating and overseeing individuals and businesses operating within the ports of this State. We will streamline this through a fair, efficient, and transparent hiring process to maintain public trust and help ensure continued economic prosperity.

### THE PROCESS

The NJSP will work to implement a review process designed to provide an efficient yet comprehensive review of all licensing, denials, suspensions, and revocation issues relative to gaining access to the port district within this State.

#### HIRING

The NJSP will collaborate with our industry partners to recognize collective bargaining agreements while working within the mandates of Chapter 324 of New Jersey Law.

#### ACCESS

Port access cards will help to ensure individuals and businesses are appropriately vetted for safe operations within the NJ port.

#### **LICENSING**

Established protocols will help create fair and impartial processes to aid in investigative inquiries and determine the suitability of applicants and licensees.

# **World-Class Capabilities**



The NJSP will strive to enhance port functions through advanced investigative techniques, cutting-edge analytic tools, and proven security methodologies.

## **ADVANCED INVESTIGATIVE TECHNIQUES**

Focus on complex long-term investigations to root out organized crime affecting the port. We will attempt to address systemic issues of port prosperity and workplace safety.

## **INFRASTRUCTURE SECURITY**

We intend to modernize security at the port through advanced technology and security capabilities, including creating an automated process to collect tips from the public. We also intend to establish partnerships with professionally trained Port Watchmen charged with thwarting crime and terror and utilize the coordinated deployment of marine and aviation assets to supplement security operations.

#### **CUTTING-EDGE ANALYTIC TOOLS**

The NISP connects and analyzes various law enforcement data from multiple sources. By incorporating our robust Fusion Intelligence Center (NJ ROIC), automation of port hiring practices, and a cadre of professional intelligence analysts, the NJSP is well-positioned to leverage information and intelligence.
