#### Regulation of Bounty Hunters

**Take notice** that pursuant to N.J.S.A. 52:14B-5.1, the rules at N.J.A.C. 13:55B were scheduled to expire on June 25, 2021. Pursuant to Executive Order Nos. 127 (2020) and 244 (2021) and P.L. 2021, c. 104, any chapter of the New Jersey Administrative Code that would otherwise have expired during the Public Health Emergency originally declared in Executive Order No. 103 (2020) is extended through January 1, 2022. Therefore, this chapter has not yet expired and the 30-day filing date pursuant to N.J.S.A. 52:14B-5.1.c has not yet occurred, therefore, pursuant to Executive Order No. 244 (2021), and P.L. 2021, c. 104, this notice of readoption is timely filed.

The rules at N.J.A.C. 13:55B are promulgated by the Superintendent of the Division of State Police in order to implement the Bounty Hunter Licensing Act (Act), P.L. 2005, c. 376. The Act provides, among other things, that there be procedures for the licensing of bounty hunters, including owners and operators of companies engaged in performing the functions, activities, or services of bounty hunters, and employees, agents, associates, and subcontractors of those companies who perform any of the functions, activities, or services of bounty hunters, as defined by the Act.

The Division of State Police has reviewed these rules and determined them to be necessary, reasonable, and proper for the purpose for which they were originally promulgated, as required by Executive Order No. 66 (1978). Therefore, pursuant to N.J.S.A. 45:19-40, and in accordance with N.J.S.A. 52:14B-5.1.c(1), these rules are readopted without amendment and shall continue in effect for a seven-year period.

**Take notice** that pursuant to N.J.S.A. 52:14B-5.1, the rules at N.J.A.C. 13:60 were scheduled to expire on February 5, 2022. The rules at N.J.A.C. 13:60 are promulgated by the Superintendent of the Division of State Police under the authority of N.J.S.A. 39:5B-32 and are being readopted without amendment. N.J.A.C. 13:60 establishes rules and regulations concerning the qualifications of motor carrier operators and vehicles engaged in interstate or intrastate commerce, or used or operated wholly within a municipality or a municipality's commercial zone. At the direction of the Superintendent, these rules have been reviewed to determine their continuing usefulness and necessity.

The Division of State Police has reviewed these rules and determined them to be necessary, reasonable, and proper for the purpose for which they were originally promulgated as required by Executive Order No. 66

(1978). Therefore, pursuant to N.J.S.A. 52:14B-5.1, and in accordance with N.J.S.A. 52:14B-5.1.c(1), these rules are readopted without amendment and shall continue in effect for a seven-year period.
