With the recommendation of the County Executive, the County Commissioners approved of a contract with Public Consulting Group (PCG) to perform the needs assessment for the period of 11/01/2023 through 10/31/2024. The assessment will identify the most pressing needs in our community related to the harms of substance use, preventing overdose deaths, and enhancing/expanding opioid use disorder prevention, treatment, recovery support and related services.

The County Advisory Council recommended following the John Hopkins Bloomberg School of Public Health Principles for the Use of the Funds from the Opioid Litigation by using evidence to guide our funding decisions. With this in mind, we decided to use the Public Health Model and started by defining the issues in our county through an Opioid Needs Assessment. This will help us develop a strategic plan to effectively address the needs of our residents.

Administrative Expenses Breakdown To ensure the successful execution of the program, we have allocated funds toward the following administrative expenses: • Salaries and Overtime: o We have compensated employees involved in outreach and the organization of various community events. These individuals are essential to the program's success, working both regular and overtime hours to meet community needs. • Hiring of Additional Staff: o To further support the Substance Abuse Office, we have hired Medical Assistants and security personnel through an agency. The medical assistants provide crucial healthcare support, while the security staff ensure the safety of employees and community members participating in the program. • Training and Professional Development: o We have allocated funds for the training of staff members to enhance their ability to deliver effective services and support to the community. This includes specialized training in substance abuse counseling, crisis intervention, and community outreach strategies. • Grant Writing Services: o To secure additional funding for the program, we have engaged a grant writing agency. This will help us obtain necessary grants to sustain and expand our efforts in combating the opioid crisis. • Funding for Community Events: o We have set aside funds to organize and execute community events aimed at raising awareness and providing resources related to opioid use and recovery. Key initiatives include: • EOHD Wellness Village: This event was a cornerstone of our public engagement strategy, where we provided crucial information on opioid awareness and demonstrated how to use Narcan. The event served as an essential platform for educating the community on opioid prevention and response strategies. • Narcan Distribution: Since April 2024, we have distributed 325 Narcan nasal sprays to community members. This distribution is part of our ongoing commitment to ensuring that residents are equipped with life-saving tools and knowledge. • Educational Seminars: We have reached out to 300 high school students, providing them with educational seminars on opiates, substance use disorders, and Narcan. These seminars are designed to inform young people about the dangers of opioids and equip them with the knowledge to respond to potential overdose situations. • Citywide Events: Throughout the year, we have organized multiple events across the city to discuss the dangers of opiates, distribute Narcan, and educate attendees on how to assist someone who has overdosed. At each of these events, our Substance Abuse Counselors and outreach team are present, offering information about our services, providing education on Narcan usage, and distributing Narcan to those in need. 	Increased community awareness (please describe):	The public engagement initiatives conducted by the East Orange Health Department (EOHD) have significantly heightened community awareness regarding the opioid crisis. The Wellness Village event and ongoing educational efforts have served as key platforms for disseminating vital information on opioid awareness, prevention, and intervention strategies. By focusing on Narcan distribution and educational seminars, EOHD has empowered residents with life-saving tools and knowledge. Narcan Distribution: The distribution of 325 Narcan nasal sprays since April 2024 has not only equipped individuals with the means to intervene in overdose situations but has also promoted conversations around opioid misuse and community safety. The regular provision of Narcan at various citywide events has reinforced the message that opioid overdose prevention is a shared responsibility. Educational Outreach: Reaching 300 high school students through seminars on opiates, substance use disorders, and Narcan has cultivated a more informed and prepared younger generation. This early intervention approach educates youth about the dangers of opioids, encouraging them to make informed decisions and enabling them to act in overdose scenarios. Citywide Events: EOHD's continued presence at citywide events has amplified awareness across diverse groups within East Orange. By engaging attendees with practical education on how to assist overdose victims, these events foster a more supportive and proactive community response to the opioid crisis. The presence of Substance Abuse Counselors ensures that participants receive comprehensive support, from understanding addiction to learning how to administer Narcan.

The amount spent on this program in this reporting period (FY 2024) is \$373,573.79. We are currently working on extending our substance abuse service hours to better meet the community's needs.
