14	efforts?	was previously done for the County Comprehensive Alcohol and Drug Plan, this was used to identify needed services and target groups, existing services and service gaps. A community Survey was also issued to the community through various County Open Public Meeting Boards and placed on the County website. An agency survey was distributed to our local agencies through the County Open Public Meeting Boards, and placed on the County website, in order to identify the needs and gaps as the agencies see them. A listening session was also advertised to the community, where members were invited to speak and provide written testimonials regarding gaps and needs for the funding. An agency listening session was also had where individuals were invited to come and speak offering testimony regarding priorities or the county. The Opioid Settlement Task Force compiled the above information and developed five funding priorities including: Community Education, Transportation, Medication Assisted Treatment (MAT), Housing and the Hunterdon County Hope One program, which were approved by the County Commissioners. Listening sessions were held in Spring 2024, the county open public meeting boards and members of the public were invited to join two public meetings and encouraged community members to provide feedback on the priorities to ensure alignment with the community needs.
