If yes, please explain.	A wealth of information, data, and feedback were gathered in the development of a strategic Plan. A comprehensive community needs assessment process was undertaken to identify needed services and target groups, existing services and service availability, and priorities for resource development and funding. A qualitative, thematic analysis of public feedback via survey, forum, and written testimony was shared with the Council in preparation for its executive planning session. To inform the Council and provide context for the Plan, pertinent data points and trends, such as opioid use disorder treatment access, drug related deaths, drug related arrests, incidence of neonatal abstinence syndrome, and so forth were gathered. This background information was presented alongside the identified gaps, priorities for funding, and recommendations identified in other related plans and planning bodies, such as the Comprehensive Alcohol and Drug Abuse Services Plan and annual report of the Opioid Fatality Review Team. Information was cross referenced with the Approved Uses, needs assessment survey results, and forum feedback on funding priorities. The Council presented a Strategic Plan at its open public meeting on May 25, 2023. It was approved by the Board of Commissioners on August 2, 2023. 		category of Approved Uses and individual Approved Uses with respect to their opinion of its importance to be developed or expanded in Ocean County. A series of forums were held in 2023 to facilitate public participation in the planning process. Two were in-person and one was conducted via Webex. All attendees were given the opportunity to speak. Attendees were also invited to complete the survey and submit written testimony. A dedicated email address was created to receive the written testimony:  OCOAC@co.ocean.nj.us. A report and thematic analysis of the feedback gathered through the public forums and a list of participants was shared with the Council in preparation for its executive planning session. Locations include Lakewood, Barnegat, Lakewood Road in Toms River, and Chestnut Street in Toms River. The program will be staffed with 2 FT clinicians, 1 part time on call clinician, 2 FT peer support specialists, and a part time driver. Staff will respond to referrals within 24 hours, conduct an initial screening with motivational interviewing techniques, and complete a comprehensive assessment with treatment recommendations and ancillary linkages. Hope Sheds Light will provide peer recovery support and financial assistance with sober living.

Certified peer recovery specialists (CPRS) will provide one-on-one support for individuals and their families to assist with supporting, advocating, mentoring, educating, and navigating systems of care. Using the Princeton UMatter Wellness Self-Assessment, staff will work with participants to create an action plan based on the seven dimensions of wellness: emotional, environmental, intellectual, occupational, physical, social, and spiritual. Care management includes warm referral handoffs to health and social services, medication-assisted treatments (MAT), HIV and HCV testing and treatment, and additional services like care coordination, holistic supports, stress management, housing, transportation, and mental health services. Sea Change will also hold peer support groups, including harm reduction peer and family support groups, virtually and in person. The agency will administer training and the provision of naloxone overdose reversal kits; host participant-driven community education and public awareness events to promote community-driven harm reduction, and health promotion; conduct community-based research and knowledge-sharing to combat stigma and improve health-seeking behavior; and host community driven peer-led events like yoga, bowling, creative projects, open mic nights, CrossFit, surfing and more. Two full time staff will be hired and trained in the model, as well as 8 other current staff. "We're Not Buying It 2.0" consists of six 45-minute sessions that are a mixture of lectures, discussion, and activities, which can delivered over 6 weeks or two sessions per week for 3 weeks. In the first year, at least 9 schools will be outreached, of the total 412 classes with 4313 students in the County. The program will be delivered at the school during the school day.

A satisfaction survey for the teachers to be done immediately. If funding continues, an evaluator will be built into the budget for a multi-year review every 3 years and at the conclusion of funding.

At least 3 and up to 4 Ocean County employers will be engaged to form company-specific Recovery-Friendly Workplace action teams. The Pathways program coordinator will work collaboratively with each team to assess current policies, recommend changes, and develop an internal communications plan and tools for employer and employee education. The training will include but will not be limited to education on harm reduction strategies, Narcan training and distribution as well information on medicated assisted treatment. Bright Harbor On-Point Services assists Manchester Township as Bright Harbor Healthcare offers co-occurring Intensive Outpatient Services for substance abuse treatment during day hours as well as in the evening. Bright Harbor Healthcare offers outpatient counseling for individuals, groups, and families with o trained experts. There are many different approaches to substance use treatment, and each person should have an individual plan of care. Sometimes Medication Assisted Treatment or (MAT) becomes part of that care plan. At Bright Harbor Healthcare, we offer comprehensive Psychiatric Evaluation and can prescribe Suboxone or Vivitrol if indicated. Recovery Coaching trained peers with lived experience can help create a recovery care plan and support you in the environment. Bright Harbor Healthcare will also provides Ambulatory Withdraw Management AWM, more commonly called outpatient detox, is a safe way to detox from opiates in an outpatient environment. Maybe you can't be absent from work, or maybe your insurance isn't willing to cover another inpatient detox. We will decide together if AWM can help you with a safe alternative to an inpatient stay. We do offer Medication Assisted Treatment alternatives as well. As such Bright Harbor is stationed on a daily basis with both Manchester Township Police Department and Emergency Medical Services and will respond at the request of the Township's Emergency Services directly to a scene to assist patients of addiction. Opioid settlement funds were also utilized for a variety of other aspects of the Township's response to fight addiction and support our residents. Through 2024 our Township's EMS has utilized Opioid funds to purchase medical training

manakins along with training equipment to begin training all Township Employees in CPR & Narcan through the American Heart Association and Rutgers University Psychology and Substance Abuse Training Program. To date 100 employees have been training and equipped with their own Narcan Kit, to keep on them at all times. The Township has also deployed Narcan into all AED's that have been strategically placed throughout the Township with possibility of deploying into all Township owned vehicles. The Township also utilized Opioid funding to replaced Medical Kits for five of the Township's police vehicles to include AED's and Narcan Kits into all Police Vehicles. These kits included two Narcan atomizers, Gloves. Bag Valve Masks, minor wound treatments, and Oxygen. As our police are often one of the first on location to Overdoses, our EMS organization provide yearly training to all of the police officers on the use of Narcan. There are current plans to roll out a similar program to all of our volunteer firefighters. The Township did utilize funds to purchase Narcan Leave behind kits for all emergency responders, per the new state law, requiring any victim of opioid addiction that is not transported to the hospital, must receive a Narcan leave behind kit. The final purchase utilizes opioid settlement funds to purchase a vehicle for the Township's community outreach programs and to be utilized by Bright Harbor Healthcare to respond to opioid addiction. The vehicle will be utilized by various entities inside the Township to provide community outreach on addiction, provide transportation of employees to our many senior villages to conduct opioid awareness and Narcan training, direct scene response to opioid or addiction crisis by healthcare professionals, and can be utilized by responders to transport individuals who require counseling or addiction services to these facilities.
