The mission of the Passaic County Department of Human Services, Division of Mental Health and Addiction Services is rooted in our commitment to ensuring that every resident has access to the resources and support they need to recover and thrive. 1. Through our services, we aim to offer a seamless process of support that focuses on Identification, Networking, and Education (S.H.I.N.E.). Our strategy includes creating comprehensive, evidence-informed solutions that address both immediate needs and long-term recovery goals. 2. Promoting Access to Safe and Stable Recovery Housing: Our Sober Living project, supported by the Opioid Settlement Fund, ensures individuals have access to structured recovery residences. This program is crucial for those in early recovery as it provides both stability and community support during a critical time. 3. Investing in Capacity Building and Workforce Training: The Training Institute initiative is designed to enhance the skills of our service providers. By focusing on evidence-based practices, I have offered training courses that include but are not limited to Harm Reduction and updated A.S.A.M. Criteria; we are committed to maintaining a high standard of care across all our services. All initiatives are aligned with our core values of accessibility, community-driven service, and ongoing education. These values reflect our commitment to meeting the diverse needs of our communities while making efficient and impactful use of the resources available through the Opioid Settlement Fund.

How did you decide the best way to use the opioid abatement funds your subdivision received this reporting year? For example, did you rely on evidence-based or evidence-informed practices or strategies, the list of Opioid Remediation uses, a needs assessment, a strategic plan, or an epidemiological analysis? If yes, please explain.

The decisions regarding the use of the opioid abatement funds were based on evidence-informed strategies and practices, as well as extensive input from our community and stakeholders. Specifically, the funds were allocated toward three main initiatives: Sober Living, the Training Institute, and the Office of Recovery Outreach. Our approach incorporated feedback from various sources, including residents engaged through our outreach stations, the Local Advisory Committee on Alcoholism and Drug Abuse (L.A.C.A.D.A.), the Mental Health Board (M.H.B.) and P.A.C./P.A.C.A.D.A. (Professional Advisory Committee/ Professional Advisory Committee on Alcoholism & Drug Abused during their monthly meetings. Additionally, the Quarterly Opioid Recovery and Remediation Fund County Advisory Council Meetings provided critical insights from a wide range of stakeholders, including public health professionals, community leaders, and service providers. 1. Sober Living Initiative: This program was designed in response to the community's expressed need for stable recovery housing options. Feedback from residents and service providers emphasized the importance of having secure environments where individuals in early recovery can focus on rebuilding their lives. Based on this input, we contracted with Structured Recovery Residences to offer both reserved and fee-for-service bed spaces, ensuring that resources are available for those most in need. 2. Training Institute: Through consultations with L.A.C.A.D.A., M.H.B., P.A.C./ P.A.C.A.D.A., and other stakeholders, we recognized the necessity of equipping our providers with up-to-date, evidence-based practices. The Training Institute was established to address this need, offering comprehensive training sessions that cover crucial topics such as Harm Reduction, legal standards in substance use counseling, and the latest A.S.A.M. Criteria. The positive feedback and high participation

Office of Recovery Outreach: Feedback from residents and local service providers underscored the importance of accessible outreach services, particularly in underserved areas. The Office of Recovery has been pivotal in expanding outreach efforts across multiple municipalities, offering Narcan distribution, substance use education, and universal screenings. The quarterly advisory meetings have helped us refine and target these services based on ongoing community input and emerging needs. By integrating evidence-informed strategies with continuous community feedback, we have been able to make well-rounded and impactful decisions on how best to allocate opioid abatement funds. This collaborative approach ensures that our initiatives are not only effective but also closely aligned with the needs and values of the communities we serve.

Enhancing Service Delivery: One outcome is to improve the effectiveness of the support services delivered, particularly in areas related to disaster response, substance use disorder (SUD), and co-occurring disorders (COD). 3. Capacity Building: The program also seeks to strengthen collaboration among stakeholders, including municipal alliances, law enforcement, and behavioral health providers, to create a coordinated response framework. Measurement and Tracking: The impact is tracked using a combination of quantitative and qualitative measures: • Quantitative Data: The reports mention collecting metrics such as the number of people reached, service utilization rates, and outcomes from specific intervention strategies. • Qualitative Feedback: Gathering stakeholder feedback, community satisfaction surveys, and case studies to assess the perceived impact and areas for improvement. This comprehensive approach ensures both the breadth (outreach) and depth (effectiveness) of the program are monitored.

1. Integration of Behavioral Health and SUD Treatment: The program focuses on integrated care models, ensuring that individuals with co-occurring mental health and substance use disorders receive comprehensive treatment. This approach is built on evidence indicating that addressing both conditions simultaneously yields better outcomes than treating each condition separately. 2. Use of Peer Support and Recovery Services: The program includes peer support strategies that align with best practices for recovery from OUD and other SUDs. Peer recovery services involve individuals with lived experience supporting others in their recovery journeys, which research shows can improve treatment engagement and retention. 3. Screening and Assessment: The program implements evidence-based screening tools to identify the presence of co-occurring disorders early. These screenings guide the development of individualized treatment plans, allowing for targeted interventions that address the unique needs of each participant. 4. Community Outreach and Education: The program prioritizes stigma reduction and community education as core strategies, recognizing that informed communities are essential in fostering supportive environments for individuals with OUD. Educational initiatives are tailored based on evidence-based messaging strategies aimed at reducing stigma and promoting help-seeking behaviors. These components, rooted in evidence-based practices, collectively contribute to a comprehensive approach for addressing OUD and co-occurring conditions.

1. Low-Barrier Approach: The program is designed as a low-barrier sober living environment, which increases accessibility for individuals struggling with OUD. This approach ensures that participants face fewer obstacles when seeking treatment and support, which is crucial for individuals with severe substance use issues or mental health conditions. 2. Harm Reduction and Continuum of Care: The program integrates harm reduction strategies and offers a continuum of care that extends beyond initial treatment. It provides support at all stages of recovery, addressing not only substance use but also co-occurring mental health issues. This comprehensive care model ensures that participants receive consistent and holistic support during their recovery journey. 3. Trauma-Informed and Person-Centered Care: The program emphasizes trauma-informed care, recognizing that many participants have histories of trauma that contribute to their substance use and mental health challenges. Additionally, the person-centered approach tailors interventions and supports based on individual needs, making it more effective in addressing both OUD and co-occurring conditions. These strategies reflect a commitment to addressing the complex needs of individuals with OUD and co-occurring disorders, utilizing approaches grounded in evidence to improve outcomes.

The RFP outlines the requirements, scope, and criteria for selecting a service provider. 2. Vendor Evaluation and Selection: Vendors submit proposals, which are reviewed and evaluated based on predetermined criteria, including pricing, service capability, and alignment with program objectives. 3. Contract Awarding: After evaluating the proposals, the contract is awarded to the vendor that best meets the needs of the program at a competitive price. 4. Ongoing Monitoring and Reporting: Once a vendor is selected, there are ongoing performance evaluations to ensure compliance with contract terms, which are documented in regular service reports.

RealFix is an outgrowth of a winning proposal to the Bloomberg Philanthropies 2021 Global Mayor's Challenge, where Paterson was one of 15 cities worldwide (out of 500+ applicants) that received \$1M to implement an innovative solution to a challenge exacerbated by COVID. The program, currently funded by the \$1M grant, has moved beyond its initial idea of providing MAT in 90 minutes via the local hospital emergency department for those who are unhoused and via telehealth for housed individuals. It now also provides complex case management, including assistance to clients in finding inpatient treatment or supportive housing, or assistance in navigating processes for obtaining identification or insurance. By addressing many of the challenges related to Opioid Use Disorder, clients are better placed to pursue long-term recovery. Our team works with a Bloomberg Philanthropies partner organization, Delivery Associates, to collect and analyze data on the success of the program, as well as plan for increased scaling. The RealFix program is therefore perfectly poised to be the main recipient of opioid abatement funds as this grant concludes. Spending will likely begin in 2025.
