10	Please share brief information on your subdivisions overarching goals and values to provide context for this year's spending decisions	The County Advisory Council recommended to the County Executive that an Opioid Use Disorder Needs Assessment occur to assist with the allocation of settlement funds. With the recommendation of the County Executive, the County Commissioners approved of a contract with Public Consulting Group (PCG) to perform the needs assessment for the period of 11/01/2023 through 10/31/2024. The assessment will identify the most pressing needs in our community related to the harms of substance use, preventing overdose deaths, and enhancing/expanding opioid use disorder prevention, treatment, recovery support and related services.
11	How did you decide the best way to use the opioid abatement funds your subdivision received this reporting year? For example, did you rely on evidence-based or evidence-informed practices or strategies, the list of Opioid Remediation uses, a needs assessment, a strategic plan, or an epidemiological analysis? If yes, please explain.	The County Advisory Council recommended following the John Hopkins Bloomberg School of Public Health Principles for the Use of the Funds from the Opioid Litigation by using evidence to guide our funding decisions. With this in mind, we decided to use the Public Health Model and started by defining the issues in our county through an Opioid Needs Assessment. This will help us develop a strategic plan to effectively address the needs of our residents.

Hispanic residents, which informs the focus on equitable and accessible services. Also, East Orange obtained data on the number of overdoses in 3 neighboring hospitals. This data also drives our decision-making.

- 3. Evidence-Based and Evidence-Informed Practices The EOHD has chosen to allocate funds to practices with a proven track record of saving lives and supporting recovery. This includes:
  -Harm Reduction: The purchase and distribution of Narcan (naloxone) at community events and through their Substance Abuse Program is a cornerstone of their strategy. This is a primary evidence-based intervention for preventing opioid overdose deaths.
- -Treatment and Professional Development: The investment in training staff in substance abuse counseling and crisis intervention ensures that the department provides care that is in line with best practices.
- -Collaborative Care: Partnering with other departments and community organizations to provide comprehensive "wraparound services" is an evidence-informed approach that addresses the complex needs of individuals with substance use disorder (SUD).

By relying on this combination of strategic planning, data analysis, and proven practices, the EOHD aims to ensure that every dollar of the opioid settlement funds is used in a way that is both effective and responsive to the needs of the East Orange community. These evidence-based practices/strategies were also provided in peer-reviewed journals and the sharing of successful "Harm Reduction" and Narcan distribution programs within and outside of the State of New Jersey.

This information helps the program understand who it is serving and whether it's reaching the target population.  * Product Dispensed: The dashboard tracks the type and number of items dispensed from the machine. This allows the program to measure the usage of specific items, such as naloxone, test strips, and condoms. High demand for a particular item indicates a critical community need. The first-of-its-kind blueprint dedicated to ending chronic homelessness in our city focused on three overarching strategies: to Better Address Street Homelessness, Improve Access and Services Throughout the Shelter System and Expand Prevention and Housing Services. The plan helped develop a vision: Newark will strive to end chronic homelessness for all individuals over the next three years through collaboration, prevention and housing. Since the launch of the plan, we have introduced several innovative and comprehensive strategies that have helped reduce the unsheltered population by 57.6% in its first year and have sustained a two-year reduction since the plan's launch in 2022.
