

#### **PAROLE OFFICER RECRUITS**

Parole supervision means that a person has served a portion of their criminal sentence in prison before being released back into the community where they are supervised by a Parole Officer. A person must abide by certain and specific rules as a condition of their parole. Parole Officers ensure that parolees follow their conditions of supervision and help them adjust to life in the community.

Parole Officer Recruits undergo both inservice and field training. They recommend the imposition of special conditions, conduct visits, conduct investigations, and perform searches of suspected parole violations. Parole Officers may also testify at revocation hearings. Job skills include critical thinking, listening, decision making, good judgment, and de-escalation.

## PAROLE OFFICER RECRUIT ELIGIBILITY REQUIREMENTS INCLUDE:

- Must pass physical fitness test
- Attend a 20-week police academy through the Division of Criminal Justice
- Must have graduated from an accredited college or university with a Bachelor's degree
- Must be at least 18 years old, resident of New Jersey, a citizen of the United States, and possess a valid driver's license
- Must pass a civil service examination administered by the New Jersey Civil Service Commission
