MINUTES OF MEETING

The meeting was called to order by Chair Mary Beth Hennessy-Shotter.

At the commencement of the meeting, Chair Hennessy-Shotter, pursuant to Section 5 of the Open Public Meetings Act, entered this announcement into the minutes of the meeting:

Voos and Bonanni. The Chair noted that a formal recognition
would take place at the February meeting.

The Chair updated the Commissioners on the status of a motion for compliance and enforcement received in Essex County and FOP Lodge 106, P.E.R.C. No. 2023-060. The Chair also updated the Commissioners on the status of a request to stay an interest arbitration hearing, IA-2024-004, pending the appeal of P.E.R.C. No. 2023-060 filed by the FOP Lodge 106.

Lastly, the Chair updated the Commissioners on the status of a scope of negotiations petition filed by Essex County in IA-2024-004.

226 (\P 50 2023), currently on appeal in the Appellate Division.
