MINUTES OF MEETING

NEW JERSEY PUBLIC EMPLOYMENT RELATIONS COMMISSION

The meeting was called to order by Chairman Lawrence Henderson.

At the commencement of the meeting, the Chairman, pursuant to section 5 of the Open Public Meetings Act, entered this announcement into the minutes of the meeting:

Furthermore on June 22, 2006, copies of an additional written "Notice of Meeting" were posted and mailed in a similar manner.

Chairman Henderson called the meeting to order. The

Commission was able to meet although much of Trenton had been

flooded the night before and many State offices were closed. Two

Commissioners participated by phone to make a quorum possible.

The first item for consideration was the minutes of the May 25, 2006 meeting. A motion to adopt the minutes was made by Commissioner Buchanan and seconded by Commissioner Watkins. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The General Counsel distributed his monthly and supplemental reports. He also noted with gratitude that Annette Thompson had just marked her 5th anniversary as secretary in the Counsel's office.

The Commission next considered the proposed readoptions of regulations governing mediation, grievance arbitration, fact-finding and interest arbitration. No public comments were received. Commissioner Buchanan moved that the readoptions be approved and Commissioner Watkins seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

consolidated for decision. Commissioner Fuller moved the draft
decision and Commissioner Buchanan seconded the motion. The
motion to adopt the decision was unanimously approved (Chairman
Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The next case for consideration was <u>Township of Middletown</u> and <u>Middletown Township P.B.A. Local 124</u>, Docket No. SN-2006-064. Commissioner Buchanan moved the draft decision and Commissioner Watkins seconded the motion. The motion to adopt the decision was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The last case for consideration was <u>Township of Franklin and PBA Local 188</u>, Docket No. CO-2006-239. Commissioner Buchanan moved the draft decision and Commissioner Watkins seconded the motion. The motion to adopt the decision was unanimously

approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).
