MINUTES OF MEETING

NEW JERSEY PUBLIC EMPLOYMENT RELATIONS COMMISSION

The meeting was called to order by Chairman Lawrence Henderson.

Commissioner Buchanan moved the draft decision and Commissioner

Fuller seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The next case for consideration was <u>Manalapan-Englishtown</u>

<u>Regional Board of Education and Manalapan-Englishtown Education</u>

<u>Association</u>, Docket No. SN-2007-016. Commissioner Watkins moved the draft decision and Commissioner Buchanan seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The next case for consideration was <u>City of Jersey City and Jersey City PSOA</u>, Docket No. CO-2006-172. Commissioner Watkins moved the draft decision and Commissioner Fuller seconded the motion. Commissioner DiNardo recused himself because he has relatives who work in the Jersey City police department. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, Fuller and Watkins).

The next case for consideration was <u>Township of Ocean and Ocean Township PBA Local 57</u>, Docket No. CO-2006-060.

Commissioner Fuller moved the draft decision and Commissioner

Watkins seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The Commission lastly considered <u>Borough of Palmyra and</u>

<u>Palmyra Police Association FOP Lodge 2</u>, Docket No. CO-2006-301.

Commissioner Watkins moved the draft decision and Commissioner Buchanan seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).
