

NJ PINELANDS COMMISSION LETTER OF INTERPRETATION (LOI): WETLAND PRESENCE/ABSENCE SAMPLE NOTICE LANGUAGE

PLEASE NOTE: An LOI is <u>not</u> required for completion of a development application. Any wetlands on or within 300 feet of the subject property will be evaluated as part of a development application.

Instructions for Applicant:

- Fill out the body of the notice with the relevant information regarding the requested LOI. All lots subject
 of the LOI must be included in the application form and public notice. Revisions to the sample language
 may be necessary in certain situations. We recommend that you submit the draft notice to the Pinelands
 Commission for approval prior to having it mailed and published.
- 2) Address a copy of the public notice to each of the owners of real property within 200 feet in all directions of the property subject of the application, based upon the certified list provided to you by the municipal tax assessor. Each notice must be sent by **certified mail**.
 - Exception If the requested LOI does not concern a specific parcel, including a requested LOI for a right-of-way or easement, then notification of property owners within 200 feet is not required.
- 3) The text of the notice shall be published for one day in the official newspaper of the municipality in which the property is located.
 - Addition If the requested LOI does not concern a specific parcel, including a requested LOI for a right-of-way or easement, then the applicant must also publish the text of the notice in any official newspapers of the Pinelands Commission having general circulation in any municipality in which the requested LOI is located.
- 4) To demonstrate that the notice requirements have been met, please provide the following to the Pinelands Commission:
 - □ A copy of the certified list of owners of real property within 200 feet in all directions of the property subject of the application;
 - □ A copy of the notice sent to property owners and the certified mail receipts for each property owner notified, if required; and
 - A copy of the notice published in the newspaper, including the name and date of the newspaper; or
 - □ An affidavit of publication from the newspaper.
