### **Pinelands Commission to discuss link between septic systems and clean water during series of special meetings**

NEW LISBON, NJ –The Pinelands Commission will hold a series of meetings in municipalities throughout the Pinelands Area in November and December to discuss the impact that septic systems have on water quality. During the meetings, Commission staff will be present to answer questions related to septic systems and will discuss how septic systems can affect public health, water quality, and property values.

“These meetings will be of great interest to Pinelands residents, approximately one-third of whom live in homes with septic systems that, absent proper maintenance, can have an adverse impact on the water supplies upon which they rely,” said Ed Wengrowski, the Commission’s Wastewater Management Coordinator.

These meetings are part of an ongoing effort by the Commission to develop programs for the management of septic systems in the Pinelands. Discussion topics will include system maintenance, resale inspections, repair options and ways in which proper operation of systems can be achieved through local management programs. The Commission is seeking input from the

At the conclusion of the project, the Commission intends to release a septic system Best Management Practices manual to help Pinelands Area municipalities comply with proposed New Jersey Department of Environmental Protection septic system management requirements
